The Executive Engineer, National Highway Division, Ahmedabad on behalf of Ministry of Road Transport & Highways Government of India invites item rate bids online for the construction of work detailed in the table given below. The bidder is advised to examine carefully all instructions including addendum/amendments to ITB, conditions of contract, contract data, forms, terms, technical specifications, bill of quantities etc. in the Bid Document.

3. Bids must be accompanied by non-refundable tender fee as indicated in Column 5 of the above table. The bidders shall also submit **Rs. 6,000/- (Rs. Six Thousand Only)** towards the cost of Tender through the portal **“bharatkosh.gov.in”** and e-generated challan to be submitted with hard copy of the bid. 4. Bids must be accompanied by security of the amount specified for the work in the column 4 of the above table.
5. Bids must be submitted online only at e-tendering portal of <https://www.morth.nic.in> and <https://www.morth.eproc.in>. on or before **12.00 Hrs. on 10/08/2023** and bids received online will be opened

on 11/08/2023 at 12.00 Hrs. by the office of the Executive Engineer, National Highway Division, Block-C, 7th Floor, Bahumali Bhavan, Vastrapur, Ahmedabad-380052 (Phone No. 079-27910992) in the presence of the bidders who wish to attend. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.

6. The rates are inclusive of cost of traffic management during construction. Contractor shall provide road signage, bollards, boards, gunny bags, sheets etc. for safety of traffic during construction period, which will be incidental to work.
7. Instructions to Bidders regarding e-tendering process:
 - (i) The complete bid documents can be viewed/downloaded free of cost from website e-procurement through CPP portal of NIC <https://eprocure.gov.in> within time period as specified in para 2 above.
 - (ii) It is mandatory for all the bidders to have class-III Digital Signature Certificate (in the name of person who will sign the bid document) from any of the licensed Certifying Agency (Applicants can see the list of licensed CA's from the link <https://eprocure.gov.in>) to participate in from e-procurement through CPP portal of NIC.
 - (iii) To participate in the e-tendering, it is mandatory for the bidders to get registered their firm/joint venture with website e-procurement through CPP portal of NIC <https://eprocure.gov.in> to have user ID & password which has to be obtained.
 - (iv) The bidders have to submit their bids including scanned copy of Bid Security online only at website e-procurement through CPP portal of NIC <https://eprocure.gov.in> in electronic format with Digital Signature.
 - (v) No proposal will be accepted in physical form except Bid Security, Tender Fee and Other Documents. The bidders have to submit their Bid Security, Tender Fee and Other Documents in hard copy (original) also on or before 18.10 Hrs. on 17/08/2023 by RPAD / Speed Post A.D. to the offices of the Executive Engineer, National Highway Division, Block-C, 7th Floor, Bahumali Bhavan, Vastrapur, A'bad-380052 (Phone No. 079-27910992).
 - (vi) Before submission of online bids, bidders must ensure that scanned copy of all the necessary documents have been attached with bid.
 - (vii) The department will not be responsible for delay in online submission due to any reason whatsoever.
 - (viii) All the information required for bid must be filled in and submitted online.
 - (ix) All documents/papers uploaded/submitted by the bidder must be legible.
8. Uploaded documents of valid successful bidder will be verified with the original documents before signing the Agreement. The valid successful bidder has to provide the originals to the concerned authority on receipt of such letter, which will sent through registered post/E-mail.
9. For any amendment/corrigendum will be upload on portal of (<https://eprocure.gov.in>). Bidders will bound to follow all amendment/corrigendum and requested to check portal (<https://eprocure.gov.in>) regular basis. Before the date and time of submission the tender.
10. Following may be noted
 - (i) Registration should be valid at least up to one month after the last date of submission of bids.

- (ii) Bids can be submitted only during the validity of their registration.
 - (iii) The amendments/clarifications to the Bid document, if any, will be hosted on the e-procurement through CPP portal of NIC <https://eprocure.gov.in>.
 - (iv) If the firm / joint venture is already registered with e-tendering portal of MoRTH, NHAI, BRO and validity of registration is not expired the firm / joint venture is not required for fresh registration.
11. Documents required to be submitted by On-line Only.
- If bidder fails to provide proof of assured availability of below required documents he will be disqualified for the proposed work.
- 1. Tender Fee (Only payment through Bharat Kosh).
 - 2. Bid Security (EMD) or EMD Exemption certificate.
 - 3. Current registration certificate Class B & Above.
 - 4. Current category registration certificate Special Road Category-III.
 - 5. Valid Bank Solvency Certificate.
 - 6. PAN Card and GST No. Certificate.
 - 7. Latest Certificates of S.E. Mechanical for updated Dram Mix plant (60-90 TPH) and Batch type hot mix plant (100-120 TPH) and as the work has to be carried out by Dram Mix plant (60-90 TPH) and Batch type hot mix plant (100-120 TPH) hence bidder has to provide proof of ownership of Dram Mix plant (60-90 TPH) and Batch type hot mix plant (100-120 TPH) or lease / hire agreement for the work under tender shall be considered as valid proof for assured availability of Dram Mix plant and Batch type mix plant. This also require with Latest Certificates of S.E. Mechanical for updated Dram Mix plant (60-90 TPH) and Batch type hot mix plant (100-120 TPH).
