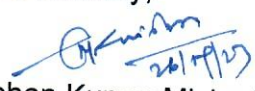

Minutes of Meeting of State Level Technical Evaluation Committee for review of evaluation of Technical Bids for the work "PR Work from Ch.98.00 to ch.112.000 of NH 327E for the year 2022-23 on EPC mode in the state of Bihar" held on 22-09-2023 in the office of Chief Engineer, NH Wing (North) RCD, Bihar, Patna.

Amount Put to the Tender: Rs. 9.094Cr.

1. The above-mentioned work was sanctioned by Ministry vide letter No File No. RW/PAT/NH/IRQP/PR/2021-22 Dated 24-07-2023 (Job No NH-327E/BR/2023-24/83) amounting to Rs. 9.62 crore. The Civil Cost of the work put to tender was Rs. 9.094 Cr.
2. Bid was invited online by Executive Engineer, N.H. Division Purnia, on 21-06-2023 with bid due date 07-08-2023 which was further extended up to 14-08-2023. Technical Bids were opened by Executive Engineer, N.H. Division, Purnia and Executive Engineer, N.H. Division, Madhepura on 17-08-2023. Following five bidders have participated.

3. The Evaluation Committee in its meeting held on 01-09-2023 has declared following bidders non-Responsive due to reason as given below:

C.K. Infrastructures Limited	The Bidders has not submitted Details of Bidder in Aneex-I and Cost of Documents through NTRP on http://bharatkosh.gov.in as per clause 2.11.1 of RFP
TITU BADWAL	The Bidders does not fulfil the requirement of Similar Projects and has not submitted year wise details of Eligible Projects in Annex VI certified by CA.
Kamac Engineers Pvt Ltd	The has been debarred by NHIDCL vide reference No. NHIDCL/AS/Jhanji-NH-37/222231/2430 Dated 19-05-2023

4. Kamac Engineers Pvt Ltd has filed writ application No CWJC 13283 of 2023 before Honourable High court Patna against the decision of Technical Evaluation Committee. Honourable High court Patna in its order dated 18-09-2023 has ordered that "the petitioner name shall be considered for the work "PR Work from Ch. 98.00 to Ch. 112.000 of NH 327E for the year 2022-23 on EPC mode in the State of Bihar" subject to result of the present petition".



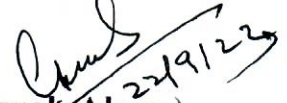
5. As per the order of Honourable High court Patna, the Evaluation Committee declare Kamac Engineers Pvt Ltd responsive for this work, subject to result of CWJC 1328 of 2023. Accordingly, the Evaluation Committee recommends to open financial bid of only responsive bidders after re-evaluation of Bid Capacity on updated existing commitments.
