The documents of technical bid of two bids received through the MoRTH <https://bims.gov.in> portal and <https://eprocure.gov.in> were downloaded and the technical evaluation was done based on the bid documents submitted on the <https://eprocure.gov.in> portal. Since Technical Evaluation through MoRTH <https://bims.gov.in> portal is not functional at present, the evaluation of technical bid is prepared manually and placed at Annexure-II.

4. The evaluations of the technical bids were scrutinized by the Evaluation Committee and the outcome of evaluation as per the pre-qualification criteria given in the RFP documents is as under.

2	Akshar Construction Company, Mehsana	Technically non responsive in light of provision w.r.t. Technical Capacity (Single similar work) as per Clause No. 2.2.2.2(iii)(a) of RFP Documents.

5. In view of the above, the committee observed that single bidder is technically responsive therefore, the Evaluation Committee recommended to re-invite the bid. The outcome of evaluation shall be uploaded on eprocure portal and 7 day's time shall be provided for receipt of comments from any of the bidders.
