IV. The State Evaluation Committee evaluated the financial bids during its meeting held on 28.09.2023 it is observed by the evaluation committee that the lowest tendered amount of Rs. 17,49,99,900/- (Rs. Seventeen crores Forty-Nine lacs Ninety-Nine thousand Nine hundred) Only has been quoted by M/s Pawansut Infra Projects Pvt. Ltd., which is 14.7714% Below the amount put to tender (based on NH Circle Bikaner BSR April 2019 put to tender).

V After deliberations, the State Evaluation Committee recommended the award of Bid to the lowest bidder M/s Pawansut Infra Projects Pvt. Ltd. at a cost of Rs. 17,49,99,900/- (Rs. Seventeen crores Forty-Nine lacs Ninety-Nine thousand Nine hundred) Only which is 14.7714% Below the amount put to tender.

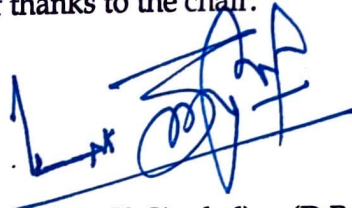
