

Minutes of Evaluation Committee held on 29.12.2023 at 11:00AM under the Chairmanship of CE – RO, MoRTH, Chennai for financial evaluation of the bids received for the work “Widening from Two Lane Paved Shoulder to Four Lane with Paved Shoulder Km 81/300 - 86/630, Km 88/600 - 90/550, Km 90/550 - 90/850 (RHS) Km 90/850 - 96/300 & 97/600 - 110/700 of NH-81 (Old NH-67 - Km 221/600-234/700, Km 236/000 - 241/450, Km 241/450 - 241/750(LHS), Km 241/750 - 243/700 & Km 245/670 - 251/000) and Strengthening from Km 81/300 - 86/500 and Km 87/600 - 96/300 of NH-81 (Old NH-67 Km 236/000 - 244/700 and Km 245/800 - 251/000) of NH-81 (Coimbatore - Chidambaram Section) (Old NH-67) (Nagappattinam-Guddalur-Mysore Road) on Engineering Procurement & Construction(EPC) basis contract in the State of Tamil Nadu.

(Job No NH- 81 (Old NH -67) - TN - 2022-23 -1019)” (Both Physically & VC)

1.The Evaluation Committee meeting was held under the Chairmanship of CE – RO, MoRTH, Chennai for further evaluation of financial bid for the work mentioned above. At the outset CE – RO, MoRTH, Chennai welcome all the participants and ask the Member Secretary to brief the matter.

2. Member Secretary informed the Committee that the Tenders received through online for the above work were opened by the State Level Tender Evaluation Committee (SLEC) on 28.08.2023. The technical bids were evaluated by the SLEC vide MOM dated 13.10.2023 & 30.10.2023. The findings of SLEC is as under:

3.The Evaluation committee vide MoM dated 06.12.2023 has accepted the recommendations of SLEC and declared the technical bids of the following bidder as "Responsive".

- (i) M/s. RPP Infra Projects Limited
- (ii) M/s. Sankaranand Infra in JV with
M/s. P Ramu & Co – (M/s. SAI - RRR(JV))
- (iii) M/s. TPC Infra and Green Energies.

4.The CE(NH), Chennai informed that the results of technical evaluation were uploaded in CPP portal. No representation has been received from any of the bidders. CE(NH), Chennai further informed that the bidder has submitted the updated value of existing commitment.

6.After evaluation of the Financial bids, the the Evaluation Committee found that the quoted price of Rs. 96,34,60,000/-(Exclusive of GST) of M/s. TPC Infra and Green Energies is 7.00 % below the amount put to tender.

7.After detailed deliberations, the Evaluation Committee agreed to recommend the lowest quoted price of Rs. 96,34,60,000/- (Exclusive of GST) of the bidder M/s. TPC Infra and Green Energies, which works out to 7.00 % below the amount put to tender for approval of Competent Authority in the Ministry.
