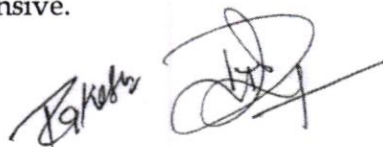

V. It is observed by the evaluation committee that all 03 (three) bidders are technically responsive.

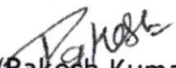
