

Minutes of meeting of Evaluation Committee held on 20.02.2024 under the chairmanship of CE (Zone-west) MORT&H for evaluation of Technical bids for the "Work of development and construction of elevated corridor from km 38/660 to km 42/690 (from Iscon Junction to Start point of approach of Sanand Flyover) of NH-147 in the State of Gujarat (length: 4.030 km) on EPC Mode".

A meeting of the Evaluation Committee was held on 20.02.2024 at 12:30 hrs to discuss the responsiveness/non-responsiveness of the bidder M/s M.S. Khurana Engineering Limited – Vidya Infra Build Pvt. Ltd. (MSKEL-VIPL) JV who has given his representation against technical evaluation results published on e-tender portal on 12.02.2024.

2. The Evaluation Committee in its previous meeting dated 08.02.2024 had declared the above bidder as technically non-responsive in terms of clause 2.2.2.2 (iii) (a1) of RFP for not meeting the criteria of completion of one similar Major Bridge/ROB/Flyover project in the last 5 (Five) financial years preceding the Bid Due Date, having span equal to or greater than 30 m and also the cost of such similar project shall be atleast Rs. 113.21 crore. The bidder vide his letter dated 13.02.2024 has submitted that they are fulfilling the requirement of clause 2.2.2.4(ii) for JV members as they have completed one similar work i.e. construction of six lane elevated structure at Gonal Chokdi at km 175 of NH-27(old NH-8B) amounting of Rs.109.15 crore the cost of which is more than 20% of Estimated Project Cost.

3. Evaluation Committee deliberated on the representation of bidder and observed that since it is a stand- alone specialized project of elevated corridor, the bidder has to also fulfil the conditions mentioned in clause 2.2.2.2 (iii) (a1) of RFP as explained above and no project in the technical bid of above bidder is qualifying the above requirement of RFP. Hence, the bidder is not meeting the requirement of RFP.

4. It was also informed to the Committee that no representation from other bidders have been received.

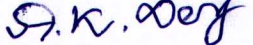
