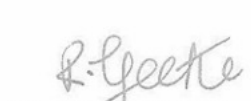
1. The chairman welcomed the committee members.
2. The tenders received through online for the subject work were opened by the SLEC on 30.08.2023. The Evaluation Committee vide minutes dated.07.09.2023 has sought clarifications from the bidder (1) M/s.IVLR Infrastructure. The technical bids were finally evaluated by the SLEC on 25.09.2023 and SLEC declared the technical bids of (1) M/s. NOTCH INDIA PROJECTS, and (2) M/s. IVLR Infrastructure as "Responsive" and the bidder (1) M/s.CDR & Co Constructions declared as "Non-responsive" The SLEC placed the Technical Evaluation report before the Screening Committee for further examination as per para 8.3 of Ministry circular No.RW/NH-24035/4/2008-P&M/PIC Vol.II, dated 23.02.2018.
3. The meeting of the Screening Committee for evaluation of technical bids under the chairmanship of Chief Engineer (SZ -II) was held on 19th October, 2023 at 2.30 P.M. at MoRTH HQ . After discussions, and detailed deliberation of Screening Committee on SLEC Technical Evaluation report and based on re-assessed bid capacity value M/s.CDR & Co Constructions is declared as "**Responsive**". The Screening Committee declared the following technical bidders i.e.(1) M/s. NOTCH INDIA PROJECTS, (2) M/s. IVLR Infrastructure and (3) M/s.CDR & Co Constructions as Technically "**Responsive**".

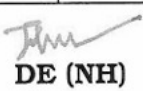

The Superintending Engineer (NH), Salem informed the Committee that the results of technical evaluation were uploaded in CPP portal on 26.10.2023 and the date of opening of financial bids was fixed on 02.11.2023. The Superintending Engineer (NH), Salem informed the committee that no representation has been received from any of the bidders in this regard.

As per clause 2.2.2.1 of RFP, Superintending Engineer (NH), Salem has sought updated value of "B" from the above responsive bidders vide Lr No. TRP 97/2023-24/DO/ Dated.26.10.2023 and requested to furnish reply on or before 01.11.2023 @ Superintending Engineer (NH), Salem informed that all the bidders have submitted the updated value of "B" within the time.

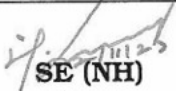

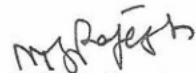
3. After evaluation of the Financial bids, the SLEC found that the bid of **M/s. NOTCH INDIA PROJECTS** amounting to **Rs. 131,64,90,152/- (Rupees One Hundred Thirty One Crore Sixty Four Lakh Ninety Thousand One Hundred and Fifty Two Only) (Exclusive of GST)** working out to **3.48% above** the estimated cost of work (SOR 2022-23) put to tender is the lowest. Accordingly, the SLEC recommended the lowest bid of **M/s. NOTCH INDIA PROJECTS** amounting to **Rs. 131,64,90,152/- (Rupees One Hundred Thirty One Crore Sixty Four Lakh Ninety Thousand One Hundred and Fifty Two Only) (Exclusive of GST)** to Screening Committee of the Ministry as per para 8.3 of Ministry circular No. RW/NH-24035/4/2008-P&M/PIC Vol.II, dated. 23.02.2018 for further evaluation.

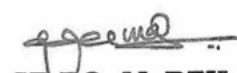

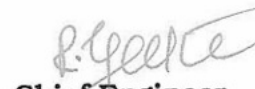
