The meeting of evaluation committee was held on 29.12.2023 and the following **04 out 05 bidders** are declared technically responsive as per RFP, therefore, financial bids of technically responsive bidders will be **opened on 18-01-2024 at 12:30 PM in the office of the Chief Engineer, PWD, National Highway Zone, Pension Bada, Raipur, Chhattisgarh** after confirmation of Bank Guarantee submitted by the technically responsive bidders against bid security and fulfillment of requirement of updated bid capacity as per **clause 2.2.2.1** of RFP:-

The technically responsive bidders shall inform the authority through email in the prescribed format enclosed at Annexure VI A of Appendix 1A of RFP, for any change in their bid capacity, due to award of/declared to be the lowest bidder in any other project as on the day before opening of financial bid. In case of no change, 'NIL' information shall be furnished. If any of the qualified bidders fails to furnish the above information due to whatever reasons, or fails to qualify in Bid Capacity in this changed scenario, his financial bid will not be opened.

One of the qualified bidder **Shri Prakash Chand Rai**, Ambikapur is also requested to furnish the **Certificate** for compliance regarding restrictions on procurement from a bidder of a country which shares a land border with India and on sub-contracting to contractors from such countries **as per format in clause 2.2.1(d) of RFP**. If **Shri Prakash Chand Rai**, Ambikapur fails to furnish the above information due to whatever reasons, his financial bid will not be opened.

The Authority may open the online Financial Bids of the remaining bidders only on schedule date and time in the presence of the authorized representatives of the Bidders, who may choose to attend.

Minutes of Meeting of Evaluation Committee held on 29.12.2023 for technical evaluation of bids for the work of Up-gradation to Two Lane with Paved Shoulder of Katni-Gumla Road NH- 43 from Ch. km 373.500 to km 375.620, length- 2.120 km on Engineering, Procurement & Construction (EPC) mode in the state of Chhattisgarh.

The Evaluation Committee in its previous meeting dated 06.10.2023 opened the technical bids of following 05 bidders for technical evaluation as per criteria mentioned in the RFP:

2. The estimated cost of the project for which bid is invited is less than Rs. 100.00 Cr. and hence Joint Venture is not allowed as per clause 2.2.1 (a) of RFP.
3. The Member Secretary presented the comparative statement before the Technical Bid Evaluation Committee.
4. As per the tender called the requirement of **bid capacity** as per clause 2.1.17 & 2.2.2.1 is **Rs. 10.43 Crore** for individual firm.
5. The requirement of **Threshold Technical Capacity** as per clause 2.2.2.2 (i) of RFP during last five financial years (2018-19 to 2022-23) for construction of eligible project is **Rs. 7.82 Crore** for individual firm.
6. Also as per clause 2.2.2.2 (ii) bidders shall have completed atleast **one similar work** of 20% estimated project cost i.e. **Rs. 2.09 Crore (Rs. Two Crore Nine Lacs only)** from the Eligible Projects in Category 1 and/or Category 3 specified in Clause 2.2.2.5.

However, no additional experience in construction of Major Bridge/ROBs/ Flyovers/Tunnel in the last 10 (Ten) financial years preceding the Bid Due Date is required, as longest span of Bridge under tender is less than or equal to 60m.
7. As per RFP the bidder shall have a minimum **Net Worth** (financial capacity) of **Rs. 0.52 Crore** as per clause 2.2.2.3 (i) of RFP.
8. As per RFP the bidder shall have a minimum **Average Annual Turnover** of **Rs. 1.565 Cr.** for last five financial years as per clause 2.2.2.3 (ii) of RFP.

9. As per RFP the bidder shall submit self-certification that the item offered meets the local content requirement for 'Class-I local supplier' as per clause 1.2.10 (i) of RFP. In case of procurement for a value in excess of Rs. 10 Crores, the 'Class-I local supplier'/ 'Class-II 'local supplier' shall provide a certificate from the statutory auditor or cost auditor of the company (in case of companies) or practicing chartered accountant (in respect of suppliers other than companies) giving the percentage of local content.
10. As per RFP the bidder shall submit a certificate on the letter head regarding shares land border as per clause 2.2.1 (d) of RFP.
11. In accordance to above fixed criteria of RFP, bid capacity, technical & financial capability of all bidders have been evaluated and the criteria of bidder's as per requirement details is attached as '**Annexure-I**' with this document.
12. The following observations are made by the evaluation committee in accordance to requirements as per RFP for above subjected work:-
- (a) The bidder **M/s S.Kumar's Associates**, Korba is found to be **technically non-responsive** as bidder is not fulfill minimum criteria of Threshold Technical Capacity of **Rs. 7.82 Cr.** as per clause 2.2.2.2 (i) of the RFP.
- (b) **Shri Prakash Chand Rai**, Ambikapur (C.G.) has not submitted the certificate for compliance regarding restrictions on procurement from a bidder of a country which shares a land border with India and on sub-contracting to contractors from such countries. **Shri Prakash Chand Rai**, Ambikapur (C.G.) is requested to submit the aforesaid certificate **as per format in clause 2.2.1(d) of RFP** within **07 days** from date of declaration of technical results, for consideration of their bid for financial opening. In case **Shri Prakash Chand Rai**, Ambikapur (C.G.) does not submit aforesaid certificate within **7 days** the bidder will be treated as non-responsive.
13. It was also apprised to the Committee that **04 bidders out of 05 bidders** fulfill the criteria of Qualification requirements of Bidders as per the condition of bidding documents.
14. The test of responsiveness of all bidders has been checked and following **04** bidders are found to be responsive as per clause 3.1.6 (Section 3) of RFP -

15. It was also apprised to the Committee that all the above bidders have submitted the Bid Securing Bank Guarantee of amounting to Rs. **10.43 Lakhs (Rs. Ten Lakhs**

Forty Three Thousand) only in the specified format as per Cl. 2.20 and Appendix-II of RFP.

16. It was also apprised to the Committee that the bid securities of the above bidders are being verified from the respective banks. This may take some time and therefore, the Evaluation Committee was of the view that all the qualified bidders may be declared technically responsive.

17. As per clause 2.2.2.1, "The Bid capacity status of the bidder to be updated as on the day before opening the financial bids."

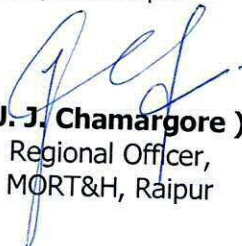

In view of above, the Evaluation Committee recommends opening of the Financial Bids of the above technically responsive bidders as per the RFP subject to verification of bid security BG from concerning bank, only if their available BID capacity (updated as on day before opening of financial bids) is more than the total BID value.
