

Minutes of meeting of Evaluation Committee held on 19.12.2023 under the chairmanship of CE (Zone-west) MORT&H for evaluation of Technical bids for the work of "Upgradation of Goras to Shyampur Road section of NH-552 Ext., from Design Chainage 48.400 to 111.800 Km (Total length 63.40 km) to two lane with paved shoulder configuration along with One time improvement of 8.91 km in the state of Madhya Pradesh on EPC mode."

At the onset, Chairperson of the committee welcome the members and informed that: -

The bids for the above-mentioned work were invited by CE-RO MoRTH Bhopal on e-tendering portal <https://eprocure.gov.in/eprocure/app> vide Tender ID: 2023_MoRTH_768349_1 on 25.08.2023 for an amount of Rs. 308.38 Cr with Bid submission end date as 01.11.2023 @ 5:30 pm and Bid opening date as 03.11.2023 @ 12:30 hrs. The technical bids were opened 03-11-2023 @ 12:30hrs in CE-RO MoRTH Bhopal office in the presence of Members of the Evaluation Committee and total 15 bids were received. The bids were handed over to Member Secretary for preparation of draft evaluation report for consideration of this committee.

2. Accordingly, Chairperson requested the Member-Secretary to present the draft evaluation as per RFP for consideration of the committee.

2.1 Member Secretary informed that BGs for Bid security of all the 15 bidders have been got verified by CE RO MORTH Bhopal. He explained the methodology of evaluation as per RFP for discussion and presented the evaluation as per **Annexure-I**. He submitted the responsiveness/non-responsiveness of the technical bids of all the 15 bidders as under:

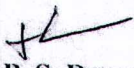
4. As per para 2.19 of RFP, the results of technical evaluation shall be displayed on e procurement web portal for 7 (seven) days also indicating the main reasons for non-responsiveness. The financial bids of responsive bidders shall be opened after assessing the updated bid capacity of the technically responsive bidders as on the day before opening of financial bids as required under clause 2.2.2.1 of RFP and disposing the objection of non-responsive bidders. Further, as per clause 3.1.9, the authority shall also inform the other bidders about their non-responsiveness.

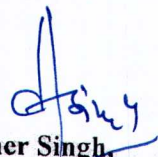

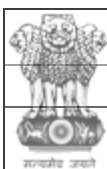
