

Minutes of Meeting for Re-evaluation of Technical Bids for the work "Construction of four-lane ROB and its approaches at the level crossing (LC No.29B) Of Km 29(Ekangarsarai) of NH-110 (New NH-33) & Railway Km 32.63 of Fatwa (FUT)-Islampur(IPR) section with Utility Shifting in the state of Bihar on EPC Mode" held on 29.02.2024 at 15:00Hrs in the office of Chief Engineer cum Regional Officer NORTH Bihar, Patna.

Amount Put to the Tender: Rs. 109.86Cr.

1. The above mentioned work was sanctioned by Ministry vide reference no.- NH-12014/30/2021/BR/NH-110/ROB-RO Patna Dated 10-03-2023 (Computer No.200028) Job No-NH-110(New NH-33)/BR/2022-23/71 amounting to Rs. 201.08 Cr. The Civil Cost of the work put to tender was Rs. 109.86 Crore.
2. The tender for Construction of four-lane ROB and its approaches at the level crossing (LC No.29B) Of Km 29(Ekangarsarai) at NH-110 (New NH-33) & Railway Km 32.63 of Fatwa (FUT)-Islampur (IPR) section with Utility Shifting has been invited for amounting Rs-109.86 crore which is inclusive of civil cost & utility shifting.
3. RFP has been invited online by Executive Engineer, N.H. Division No-2 Bihar Sharif Vide MIT No-NH/BSF/EPC/01/2023-24 dated-24-08-2023 with bid due date 12-10-2023 which was further extended upto 13-11-2023 vide corrigendum-1, upto 29-11-2023 vide corrigendum-2 and upto 18-12-2023 vide corrigendum-3. Technical Bids were opened by Executive Engineer N.H. Division No-2 Bihar Sharif on 19-12-2023. Following Eight bidders have participated.
