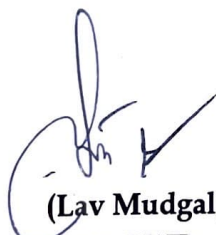
VII. Member Secretary of the committee informed that the combined score of all the above mentioned Two (2) technically responsive bidders have been worked out in accordance with the procedures specified in Para 5.4 of the Letter of Invitation to Consultant, the applicant having highest combined score is ranked H-1. Details are as under:

VIII. The committee observed that as per details given in para VII above M/s JSV Technocrats LLP having the highest combined score of is ranked as H-1.

IX. After the detailed deliberation, the Evaluation committee has recommended to accept the offer of **Rs. 10,90,320.00 (Rs. Ten Lakhs Ninety Thousand Three Hundred Twenty Rupees Only)** of first ranked bidder (H-1) namely **M/s JSV Technocrats LLP**. Accordingly, the Evaluation committee recommended and award of assignment to **M/s JSV Technocrats LLP** as deliberated above.
