3.1. The bids uploaded on e-Tendering portal by all the above mentioned bidders were evaluated based on the stipulated criteria of RFP.

3.2. After Reviewing the Bid documents of the bidders,evaluation committee found that the;

- (i) The Bidder shall also submit Rs. 11,800/- [Rs. Eleven thousand Eight Hundred only] towards the cost of tender [Tender fee Rs. 10,000/ + 18% GST amounting to Rs. 1800/- to be submitted through the portal bharatkosh.gov.in(scanned copy of receipt / document to be submitted online on eprocure.gov.in] in favour of 002192 - Regional Pay & Accounts Office, DDO-203945-SE, Civil, Bhopal] but the bidder **M/s. Jeet construction Co., Gurugram** has submitted the above required amount to National highway Authority of India (Account no- 8598201005819, IFSC code-CNRB0008598).Hence the evaluation committee

considered the bidder M/s. Jeet construction Co., Gurugram as Non Responsive.

- (ii) The bidder is required to submit the documents required in Annexure -I of appendix 1A i.e details of bidder in proper format as per RFP, but the bidder M/s. Shri Buildup Pvt.Ltd. Chhattarpur(m.p.) has not submitted the above documents in proper format as per RFP.Hence the evaluation committee considered the Bidder M/s. Shri Buildup Pvt.Ltd. Chhattarpur (m.p.) as Non Responsive.

- (iii) The evaluation committee ask the bidder M/s. Rajdeep Constuctions Company ,Betul MP to submit the Updated bid capacity of the firm but bidder fails to submit the same and hence evaluation committee calculate the bid capacity of the bidder and found that bidder is not qualifying in the criteria of the required Bid capacity as per RFP clause 2.2.2.1 i.e 14.69 Cr.

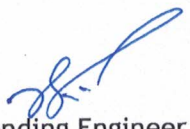
