

Review Minutes of Meeting of the Evaluation Committee under the chairmanship of CE-NH Bhopal held on 09.09.2024 at 4.00PM for evaluation representation on Technical result of the work of "One Time Improvement in Bhoura Town Portion, Shahpur Town Portion & Padhar Town Portion on NH-69 (Old) NH-46 (New) Itarsi Betul Road in the State of Madhya Pradesh on EPC Mode."

The online tenders through e-tendering Portal <https://eprocure.gov.in/eprocure/app> for the above-mentioned work was called by CE(NH), MPPWD, Bhopal vide Tender ID: 2023_MoRTH_770427_2 on 01.05.2024. Bhopal and details of the bids are as below:-

- i. Date of Sanction/ Cost- 27.09.2023/ 17.34 Cr.
 - ii. Amount put to Tender – Rs. 14.69 Cr.
 - iii. Bid due date -19.06.2024
2. The result of technical evaluation was hosted on portal on 25.08.2024 for 07 days accordance with clause 2.19 & 3.1.9 of RFP, in which out of total 06(five) bidders only 02 bidders were found technically responsive.

3. All the above mentioned bids were evaluated based on the stipulated criteria of RFP and documents uploaded by bidders on e-Tendering portal. Based on the data submitted in the bid of each bidder the technical evaluation has been carried out as per the criteria stipulated in the RFP.

4. The result of Technical Evaluation was hosted on the portal on dated 25.08.2024. The bidder was given an opportunity for representation by 02.09.2024, if any. Following three bidders have submitted their representation, which are evaluated by Technical Evaluation Committee and the gist given as below:-

4.1 **M/s Ram Raja Construction Company** has submitted their representation via mail on 27.08.2024 & 28.08.2024 in which bidder encloses *(i) local content certificate signed by statutory auditor as per cl. 2.11.1, (ii) updated value of 'B' which is not signed by statutory auditor as per Annexure VI and, (iii) bidder has not submitted an undertaking as per cl. 2.11.1(j) of RFP document within due date.* Hence, Evaluation Committee considered the bid of **M/s Ram Raja Construction Company** as **Non-Responsive** as per cl. 3.1 of RFP document.

4.2 **M/s Amar Engicon & Construction Pvt. LTd.** has submitted their representation via mail on 26.08.2024 & 28.08.2024, in which they have submitted *(i) updated value of 'B' and qualifies in the criteria of Bid Capacity as per Cl 2.2.2.1 of RFP. (ii) Also claim their work having title " O.T. for Composite work (Engineering and Electrical) for Panel Interlocking of Jagdishpur, Maheshmunda, Giridih sections in Madhupur- Giridih section under DEN/2/ASN"* as at least one similar work as per cl. 2.2.2.2 (ii) of RFP, Evaluation Committee gone through the same and found that the there is nowhere mentioned in experience certificate that it is a linear work of construction/reconstruction of railways track or yards to consider this as a similar nature of work. Hence, Evaluation Committee considered the bid of **M/s Amar Engicon & Construction Pvt. LTd.** is **Non-responsive** as per cl. 3.1 of RFP document.

4.3 **M/s Siddhartha Laxmi Engitech Pvt. Ltd.** has submitted their representation via mail on 09.09.2024 after due date i.e. 02.9.2024, also in the submission again bidder has not submitted the *signed copy of Local content certificate by statutory auditor* as per cl. 2.11.1 of RFP. Hence, the representation submitted by **M/s Siddhartha Laxmi Engitech Pvt. Ltd.** has not considered as per cl. 3.1 of RFP document.

5. After reevaluating of bid as per representation submitted by the bidder, following 02(Two) bidders are found technically responsive and evaluation committee opined that financial bids of responsive bidders may be opened.
