

Minutes of Meeting of Evaluation Committee
Held on 01.09.2025 under the Chairmanship of Chief Engineer, NH Zone, MP PWD, Nirman Bhawan, Bhopal for evaluation of Technical Bid for the work of:-

“One Time improvement in Bhoura town portion, Shahpura town portion and Padhar town portion on NH-69 (Old) NH-46 (New) Itarsi Betul road in the state of Madhya Pradesh on EPC mode.”

1. The online bids for the above-mentioned work were invited through the e-tendering portal <https://eprocure.gov.in/eprocure/app> by CE(NH), MPPWD, Bhopal vide Tender ID no. 2023_MoRTH_770427_3, Bhopal, dated 29.05.2025, with the following bid details:-
 - i. Date of Sanction/Cost: **27.09.2023 / Rs.17.34 Cr.**
 - ii. Project Cost: **Rs. 14.69 Cr. (Excluding GST)**
 - iii. Bid Due Date: **01.07.2025**
 - iv. Bid Opening Date: **03.07.2025**
2. The technical bids were opened by the Office of the CE (NH), MPPWD, Bhopal on 03.07.2025. The following 04 (Four) firms participated in the tender:-

- 3.1. The bids uploaded on the e-Tendering portal by the above-mentioned bidders were evaluated based on the stipulated criteria of the RFP. The evaluation sheet is enclosed herewith as Annexure-A.
- 3.2. The Committee observed that out of the total 04 bidders who participated in the bidding process, all bidders were found technically responsive. The details of the evaluation are as follows:-

4. It was apprised that as per the available records known to the committee, none of the 04 responsive bidders are debarred or blacklisted and all bidders have valid bank guarantees, which have been duly verified by the respective banks.
5. The bidders were given 07 days time to submit their representation, if any after hosting of the results of technical evaluation on web portal as per clause 2.19 of the RFP. Subsequently, out of 04 four bidders, one of the bidders raised objection against the other bidder. The objection was duly reviewed and discussed upon in the evaluation committee, however the decision with respect to responsiveness of the bidders remains unchanged as per the earlier uploaded result on the CPPP Portal.

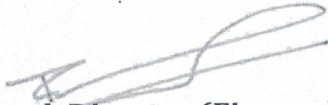
