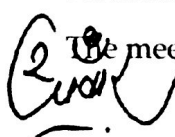

iv). State Evaluation Committee examined the relevant documents submitted by bidders & evaluated "Proof of Eligibility" & Technical Proposal as under:-

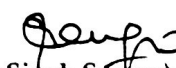

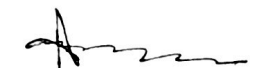
