

Minutes of Meeting for Technical Evaluation of the bids for "Construction of four-lane of Chausa – Buxar Bypass from km 45.000 to km 65.915 (Package-2) of NH-319A in the state of Bihar on EPC mode in the state of Bihar".

A meeting was held on 05.03.2024 under the Chairmanship of Chief Engineer, Zone, East for Technical Evaluation of the bids for "Construction of four-lane of Chausa – Buxar Bypass from km 45.000 to km 65.915 (Package-2) of NH-319A in the state of Bihar on EPC mode in the state of Bihar".

2. The committee was informed that as per its earlier meeting held on 26.02.2024, the result of technical evaluation was uploaded on CPP Portal. M/s CEIGALL INDIA LIMITED was declared non-responsive as the company was not fulfilling the Bid Capacity criteria as M/s CEIGALL INDIA LIMITED has referred NHAI circular No. 9.1.12 dated 10.03.2022 while calculating bid capacity at Sl. No. 13 & 14 under table to calculate value of B. The committee noted that there is no such provision in the RFP and the bidder is required to mention the value of all existing commitments in order to calculate the value of B. The committee calculated the value of B value which came to Rs. 9558.89 Cr. Accordingly, the Bid Capacity was calculated and bidder was found to be technically non-responsive.

The committee was further informed that M/s. CEIGALL INDIA LIMITED vide letter dated 28.02.2024 has submitted a representation in view of technical result dated 26.02.2024. M/s CEIGALL has re-submitted its Bid capacity in accordance with the qualification criteria as prescribed under clause 2.2.2 certified by the CA. The required Bid Capacity is Rs. 632.45 Crore as per RFP and the available Bid capacity with the bidder is Rs. 996.63 Crore. The Committee noted that M/s CEIGALL had submitted the B value with and without GST while submitting the bid. While evaluating earlier, the Bid capacity was calculated considering the value of B with GST. However, the Bid capacity shall be calculated considering the value of B without GST. Accordingly the Committee re-calculated the Bid Capacity and found that M/s CEIGALL is qualifying the minimum criteria required as per RFP. The committee examined the submissions made by the bidders and found that the bidder is qualifying the minimum requirement under the RFP. Therefore, bid of M/s. CEIGALL INDIA LIMITED was declared as technically responsive.

3. In view of the above, the committee deliberated that, with this technical evaluation of the bids has been completed and recommended to open financial bids of the following bidders:

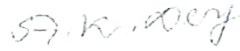

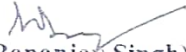
