

Minutes of Meeting of Technical Evaluation Committee held on 02.11.2023 in the chambers of Chief Engineer, National Highways, Bangalore for evaluation of technical bids of One Time Improvement proposal for the bypassed sections of Bidadi, Ramanagara, Channapattana, Maddur, Mandya and srirangapattana city limit in Bangalore-Mysore section of NH-275 (NHAI DC Work)

Sanctioned cost: Rs.105.80 Crores, Civil Construction Cost: Rs. 105.80 Crores. (Including GST 18%) through Standard Bidding Document (SBD) mode.

Preamble:-

The Regional Officer, National Highway Authority of India, Head Quarters has accorded approval to estimates amounting to Rs. 105.80Cr for one time Improvement of Bypassed section in following town limits Under head of account 8443 Deposit contribution vide letter No.NHAI/PIU-RMNG/NH-275/13025/10/2023-24/1200 Dtd:11.09.2023.

The technical bid documents substantiating the Qualification Criteria indicated in the SBD conditions .

- 1) Bid security as per clause 15&16.
- 2) Annual turn over report in all clause of civil engineering as per clause 2.6.3(a) and 1.2 of section 2
- 3) Work done certificate for similar nature of works- single prime contractor as per clause 2.6.3(b).
- 4) Financial position(Cl 2.6.6)
- 5) Audited balance sheets (Clause 2.6.4)
- 6) Personnel capabilities (Cl 2.6.4)
- 7) Equipments as per Annexure-II vide section1.
- 8) Bid capacity as per clause 2.6.9.

After detailed verification of documents with respect to above qualification criteria the committee tabulated the responsive and the non responsive bidders and findings of the committee for each work were appended vide Annexure -I.

Conclusion:-

The committee directed the Executive Engineer NH Division Bangalore to:

- (i) Publish the proceedings in the Ministry e- Proc portal before opening the Financial Bid.
- (ii) An undertaking from the successful bidder has to be obtained for deploying the required Machineries and also required Key personals as per IFT at site.
- (iii) An undertaking from the successful bidder that all the required machineries will be kept in good working condition till completion period and the undertaking given by the L1 bidder will become the part of agreement.
- (iv) In case of bidders who have participated in more than one tender, the financial bids are to be opened sequentially, based on the bid capacity. The stage at which the bid capacity exhaust, further financial bids of such bidders shall not be opened.
