

Sub: Minutes of meeting of the evaluation committee dated 16.11.2023 for the technical evaluation of the bids for the Engagement of supporting staff on purely temporary basis through placement agency for Regional Office, MoRTH Jammu.

The bid for the subject work (3rd call) has been invited through CPP portal vide NIT dated 04.10.2023 (Tender ID: 2023_MoRTH_774608) with last bid submission date on CPP Portal as 19.10.2023. The bid was opened on 20.10.2023 wherein bids from the following 09 bidders were received.

2. As per clause 4.2 of LOI of the RFP, the bidder was required to submit following documents physically:

(i) Bid Security amounting to Rs.10,000/- (Rupees Ten Thousand only) in form of Demand Draft issued by any of the Nationalized and scheduled Bank of RBI in favour of RPAO(NH), Chandigarh.

3. As per clause 5.1 of the **Datasheet** in RFP, *"The placement agencies should have minimum Three (03) year experience for providing manpower to reputed Private Companies/ Public Sector Companies/Banks and Government departments and should be registered by the various Authorities, required for a placement agency"*. Further, as per clause 5.2 of the **Datasheet** in RFP, Placement agency is required to furnish the following documents in the technical bid:

- i Copy of experience certificate, issued by the employer, of last three years.
- ii Copy of Income Tax PAN Card.
- iii Copy of valid GST Registration Certificate.
- iv Copy of the valid Registration Certificate (Employers code number) issued by the RPFC Authority in the name of the Agency/Firm as per the EPF Scheme.
- v Copy of valid Registration Certificate under ESI Authority and Employer's Code.

vi Copy of valid labour license issued by the Competent Authority in the name of the Agency/Firm under the Contract Labour (R&A) Act. 1970.

4. The 09 bids as downloaded from CPP Portal were evaluated technically keeping view of terms and condition as mentioned in the RFP. It was found that the bidder M/s ABN PERSONNEL NETWORK has submitted the bid security amount of Rs 10,000/- in the form of demand draft. whereas the following bidders are registered under MSME and therefore exempted from payment of bid security as per certificate issued by NSIC.

Further, one bidder namely M/s Viutil Infra Private Ltd has submitted only signed RFP and has not submitted any experience certificate of the last 3 years or other documents as required under para 5 of the datasheet of the RFP. Similarly, bid of another bidder namely M/s Kanshi Nath Bhagat, has been found deficient as he has not submitted technical bid as per the RFP provisions. Also, experience certificate and other documents as mentioned in para 3 above has not been submitted by the bidder.

5. In view of the above, committee declares the technical results of evaluation of bids as below:
