With reference to the above subject, the work of "**Patching Of Pot Holes From Km 164.00 to Km 194.555 of National Highway-73 Mangalore Tumkur Section In The State Of Karnataka under FDR 2023-24 (JOB NO.TA-73-KNT-FDR-2023-24-96)**" is technically, administratively and financial approved by the Ministry in their letter cited under ref (1) above for Rs. **Rs.47.59** lakhs by assigning JOB NO.TA-73-KNT-FDR-2023-24-96.

Further, the Technical Sanction to the estimate for the above work was accorded by Chief Engineer, National Highways, Bengaluru by assigning **CER No.17/2023-24** for **Rs.47.59** lakhs under FDR Major Head - 3054: Roads and Bridges, 01-National Highways (Sub-Major Head), 01. 337 Road Works (Minor Head), 01-Maintenance by Roads Wing, 01.02 Maintenance by Roads wing Financed from Central road Infrastructure fund, 01.02.29 Minor Works for which the corresponding demand for the current financial year 2023-24 is '86'- ministry of Road Transport & Highways vide letter cited under ref (2) above and draft tender schedule was approved by this office.

The short term tender permission was accorded by the superintending Engineer, National Highways Circle, Bengaluru vide letter cited under ref (3) above.



Accordingly, the short term tender Notification for this work was notified vide NIT No.EE/NHD/HSN/AE-1/FDR/NIT/2023-24/03, Date:10-10-2023 for submission of tender through online on CPP Portal <https://eprocure.gov.in>. As per the tender published in the CPP Portal the tender events are as follows:

Last date & time for/ Clarifications/queries : **12.10.2023 up to 17.30 hrs**

Last Date & Time of Receipt of tenders : **16.10.2023 upto 16.00 hrs**

Date & Time of opening of Technical bid : **17.10.2023 @ 16.00 hrs.**

The tender was opened in the CPP portal <https://eprocure.gov.in> on 17-10-2023 and found that the following three bidders have participated, namely.

1. **Sri S.H Chandre Gowda Class-I Contractor, Sri. Lakshmi Ranganath Nilaya, Singamma Temple Main Road, Holenarsipur, Hassan District.**
2. **K.S.Ashwathanarayana Gowda S/o K.M Shamaiah, Class-I Contractor, Behind R.M.C.Yard Channarayapatna, Hassan District.**
3. **Sri G.K.Ravikumar, Class-I Contractor, Gowdagere, Channarayapatna Taluk, Hassan District-573116.**

As per documents submitted by the bidders and after verifying the EMD and Tender Document Fee, it was found that the all the three bidders were submitted stipulated EMD through FDR and paid Tender Document Fee, hence it was found in order.

The documents uploaded by the bidders are verified and evaluated with the stipulated conditions and criteria's, technical evaluation comparative statement has been prepared and accordingly the bidders who have participated fulfils the stipulated conditions and criteria's and their bids are found responsive.

Further, the financial offerings of all the three bidders were tabulated and financial bid comparative statement has been prepared and enclosed are as follows.

As per the above Comparative Statement, the rates quoted by the bidder **Sri G.K.Ravikumar (L1)** which amounts to **Rs.44,18,426.67 (Rupees Forty Four Lakh Eighteen Thousand Four Hundred and Twenty Six and Sixty Seven Paise only) inclusive of GST**, which works out to be 0.03% Below to the amount put to tender as per sanctioned estimate and 5.13% below to the amount put to tender as per CSR and it is the lowest tender.

As per the clause 3(a) of delegation of financial powers vide Government order No:PWD:423:FC-1:2018:Bengaluru, Dated:24.09.2018, the approval of this tender is within the limits of power of the Executive Engineer. Accordingly, the lowest tender is considered for approval and hence the following order
