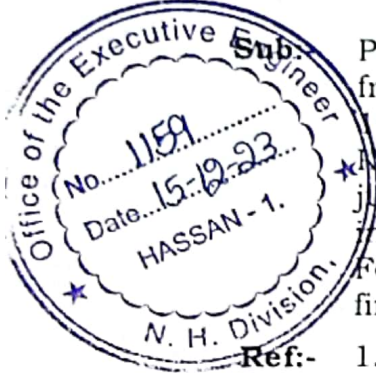

Ravikumar, Class I Contractor, Gowdagere ,Kasaba Hobli,Channarayapatana taluk, Hassan District ,amounting to Rs.63,96,366.49 (Rupees Sixty Three Lakhs Ninty six Thousand Three Hundred and Sixty Six & Paise Forty Nine Only) which is 6.80% below the amount put to tender on sanctioned estimated rates is approved.

The approval is communicated subjected to the conditions stated below:

- 1) While issuing, it shall be ensured that the amount of Schedule-B (BOQ) shall not exceed the approved amount and the copy of the work order shall be submitted to this office.
- 2) The specifications, Unit, Quantity of each item, shall be as per BOQ of approved DTS.



- 3) The availability of equipment, materials, key personnel's as specified in the uploaded tender documents with the contractor shall be ensured ~~before~~ entrusting the work.
- 4) The uploaded tender documents along with the drawings, conditions and relevant MORTH specifications etc., shall be part of work order/agreement.
- 5) The period of completion should be as per the NIT.
- 6) The methodology, PERT chart and Bar chart may be obtained from the bidder.
- 7) The mandatory quality tests for the materials and the finished items as per MORTH specification (5th revision) has to be strictly followed and a certificate for succesful completion in accordance to quality has to be obtained from the competent N.H.Qulaity control officials.
