3. Following 03(Three) bidders uploaded the technical bids on BIMS portal <https://bims.gov.in> & on <https://epcoure.gov.in> portals .

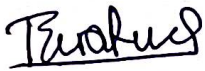

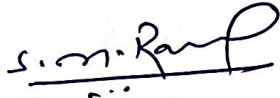

The evaluations of the technical bids were scrutinized by the Evaluation Committee and based on the technical evaluation, the Evaluation Committee decided to declare the following 03(Three) bidder **technically responsive** as per the pre-qualification criteria given in the RFP documents in EPC mode.
