

MINUTES OF FINANCIAL BID EVALUATION COMMITTEE MEETING HELD ON 06.01.2024 FOR THE WORK "Short Term Maintenance Contract (STMC) for the year 2023-24 to NH-15(From km 1.000 to km 10, 11 th to 12th, 16th to 19th, 27th to 29th, 50th, 81st, 95th (360 m), 100 to 109) (Total Length =31.360 km) under P.W,D., Rangia NH Division, Rangia in the state of Assam"(RW/GHT/STMC/AS/23-24/10)

BID VALUE: Rs. 2,26,41,862.00 (Including 18% GST & 1% L.C.)

Based on the recommendation of the Bid Evaluation committee (BEC) in the Minutes of Technical bid evaluation meeting held on 18.12.2023, the financial bids of the 4(Four) technically responsive bidders were opened on 26.12.2023 by the B.E.C under the chairmanship of Chief Engineer PWD, (NH Works) Assam and in presence of the Executive Engineer, Rangia NH Division, Member Secretary, BEC; the SE, PWD, Nalbari NH Circle, Nalbari, Member, BEC; the Deputy Secretary (Highways), Public Works (B & NH) Department, Dispur, Guwahati-6, Member, BEC; the Financial Advisor, PWD, Assam, Chandmari, Guwahati-3, Member, BEC and bidders/ bidder's authorized representatives. The summary of the financial bids opened is as follows:

Since the lowest bidder **M/s Raj Kumar Jain, 401, Amaze Shopping Mall, A.T. Road, Guwahati-781001** has quoted **33.30 % Below** the amount put to tender, BEC Decided that Performance security and additional Performance security shall be realized from the L1 bidder keeping with provision of clause 32.1 & 32.2

of RFP and concluded that it is necessary that the L1 bidder provides a justification for their bid price, which is 33.30 % below the cost put to tender (considered an abnormally Low Bid-ALB) and same shall be verified by the concerned Executive Engineer (i.e., Rangia NH Division).

The Bid Evaluation Committee (BEC) further commented that the work may be awarded to L1 bidder **M/s Raj Kumar Jain, 401, Amaze Shopping Mall, A.T. Road, Guwahati-781001** at their quoted final bid price of **Rs. 1,51,02,121.95** which is **33.30% below** the amount put to tender subject to verification and acceptance of the justification of the L 1 bidder by the BEC.

The comparison of rates quoted by the 4 (Four) technically responsive bidders considered for financial evaluation is depicted in the Comparative Statement attached herewith.
