

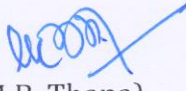

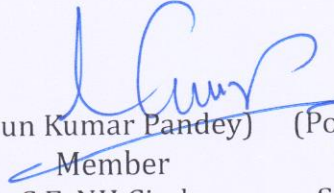
The work **"Construction of 175.60 M. Span PSC Box Bridge Over Panod Nala Ramnagar to Buwakhhal Motor Road Near Km Stone No. 44 NH-309 Ramnagar, Distt Nainital under EPC mode"** has been sanctioned vide Ministry's letter no. RO/UK/Annual Plan/2023-24/Haldwani/04 (Computer No 229204) Dt. 12.01.2024 for 29.67 Cr. **(Job No: RO/UK/Annual Plan/NH-309/2023-24/674)**

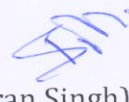
1. The bids for above work were invited through E-tendering by Superintending Engineer, N.H. Circle, PWD, Haldwani vide his letter No. 3879/12M-NH-2023, Dt 21-10-2023. The estimated project cost for the work is Rs 22.49 Crore (excluding GST).
2. The technical Bids were evaluated by evaluation committee on 23.01.2024 and publish Minutes of the meeting on the e-procurement portal. The committee recommended that bids of following Two Bidders were found Technically Responsive and recommended that the financial bids of all Two Bidders will be opened after 7 days of uploading the response on portal. The Financial bid has been opened on 02.02.2024.
 - 1) M/s ARKS Universal (P) Ltd, Ballupur, Chakrata Road, Dehradun.
 - 2) M/s Himalayan Construction 250, Sarthi Vihar Dehradun, Uttarakhand.
3. The meetings of Evaluation Committee chaired by CE NH PWD Dehradun held through Google meet on 02.02.2024.
4. Evaluation committee opened the Financial Bids of the Technically Responsive Bidders on E-procurement portal. The details of quoted price as downloaded from e-procurement portal is given below and statement from e-procurement portal is enclosed as Annexure 1 & 2.

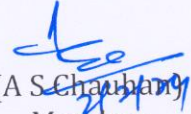

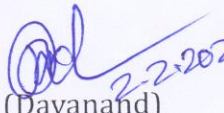
5. Committee found that quoted Price of Rs 18,43,00,000.00 (Eighteen Core Forty Three Lakh only) by M/s ARKS Universal (P) Ltd, Ballupur, Chakrata Road, Dehradun lowest. Thus as per clause 3.3.1 of RFP the committee recommended that M/s ARKS Universal (P) Ltd, Ballupur, Chakrata Road, Dehradun may be declared as selected bidder.
