- 4) The brief Qualification Parameters for technical evaluation are as under:

Project Cost: Rs.15.41 Cr.

Minimum Bid Capacity: Rs. 15.41 Cr.

Eligible Technical Threshold Capacity: Rs. 11.56 Cr.

Eligible Completed Single similar work: Rs. 3.08 Cr.

Eligible Financial Capacity: (Net Worth): Rs.0.77 Cr.

Minimum Average Annual Turnover: Rs. 2.31 Cr.

Local Content Supplier Certificate from the company's Statutory Auditor or Cost Auditor with minimum 50% usage of Local Materials.

- 5) In the above meeting, out of the 03(Three) bidders, 02 (Two) bidders have qualified in above mentioned minimum Technical and Financial criteria and 01(one) bidder has been disqualified. The brief details of evaluation are as follows: -

Also, it has not submitted online- C.A.'s Certificate w.r.t. Local Content.

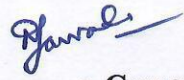
The same has been approved by the Evaluation Committee.
