The meeting of the Evaluation Committee was held on th December 2023 in Superintending Engineer National Highway Circle, Vadodara for evaluation of Short Term Improvement and routine maintenance work between Km. 388/0 to 405/305 ferkuva- Chhotaudepur- Bodeli- Naswadi road of Nh.56 in the State of Gujarat. 4. The evaluations of the technical bids were scrutinized by the Evaluation Committee and based on the technical evaluation, the Evaluation Committee decided to declare the following 01(One) bid technically responsive as per the pre-qualification criteria given in the RFP
The outcome of Technical Evaluation as per RFP document is as detailed below:-

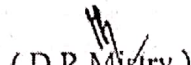
