The Ministry has approved 2 nos of ROB/RUBs have been sanctioned under SETU BANDHAN scheme under Central Road Infrastructure (CRIF) scheme approved by Ministry during 2022-23 under N.H. Division, Vijayapura jurisdiction vide MORTH, NewDelhi letter No: J-12022/1/2023-Zone-3/219 Dt: 25-05-2023. The Preparation of FS/DPR for the work of “Consultancy Services for Preparation of Feasibility/DPR for Construction of ROB to “Banashankari- Lakmapur- Km 9.50 (Near Lakmapur Village) LC No.28 including approaches in the state of karnataka” Further, The Chief Engineer National Highways Bangalore vide letter No: CNH/TA-4/JE-1/ROB-RUB/CRIF/FS-DPR/RFP/2023-24/1148 Dt:30.08.2023 has approved the RFP.

The tender notification was issued vide this office notification no: 364 Dt: 09.08.2023, fixing last date of receipts of tenders on 28.11.2023 and opening of technical bids on 13.12.2023. For this one bidder has participated in the tender.
