

Minutes of meeting for Evaluation of Technical bids held on dt. 12.01.2024 in the Chairmanship of Chief Engineer (NH), PWD, Dehradun for the work of Short-Term Maintenance from km 35 to Km 44 including Protection work (R/wall) on NH-534(Old No. 119) in the state of Uttarakhand Under STMC 2023-24.

The work "Short Term Maintenance from km 35 to Km 44 including Protection work (R/wall) on NH-534(Old No. 119) in the state of Uttarakhand Under STMC 2023-24." was sanctioned vide Ministry's letter No. RO/UK/STMC/2023-24 dated 20.12.2023 for Rs. 4.86 Cr, (Job. No. RO/UK/STMC/2023-24/05 Dated 20.12.2023. The cost of work proper is Rs. 3.79 Crore (Excluding GST).
3. The tender for the instant work was invited as per Ministry's Guidelines by the Superintending Engineer, 10th N.H. Circle, PWD, Dehradun vide letter No. 8001/13Yata-NH-10/2023 dated 22.11.2023 with online bid submission date as was fixed as 29.12.2023 while opening of online received bids was scheduled on 30.12.2023.
4. Member secretary informed that 04(Four) bidders submitted the requisite physical tender document as per the clause 12.2 of section-2, Instructions to bidder of RFP. Out of 4(Four) 1(one) bidder namely M/s Sidhballi Construction, Patel Marg, Kotdwar, Pauri Garhwal did not submit the Tender Fee of Rs. 10000/- in the name of firm, hence the bidder M/s Sidhballi Construction, Kotdwar is declared Non Responsive for opening of his technical bid online.
5. The following 3(Three) bidders submitted the requisite physical tender document as per the clause 12.2 of section-2, Instructions to bidder of RFP. Hence technical bid of the following 03 (Three) bidders were declared Responsive for opening of their technical bid online on dt. 30.12.2023.
 - (i) M/s KRV & Associates, R/O F-110, 1st Floor, Aditya Corporate Hub, RDC Rajanagar, Ghaziabad.
 - (ii) M/s N P Buildwell Pvt Ltd., 102 First Floor, Devika Chamber, RDC Rajnagar, Ghaziabad.
 - (iii) M/s Raja Infraconstruction Pvt.Ltd. B-38, RDC Rajnagar, Ghaziabad.
6. Member secretary informed that the bidder M/s Omprakash Singh, Julabpur Gudar, UFR Subhash Nagar, Najibabad, Bijnor made a representation/complained vide letter No. 01/COMPALAIN/T/S.E./N.H.10th dated 30.12.2023 in which the bidder deliberated for non submission of the requisite physical tender document as per the clause 12.2 of section-2, Instructions to bidder of RFP. Later on the same bidder M/s Omprakash Singh, Julabpur Gudar, UFR Subhash Nagar, Najibabad, Bijnor informed/expressed vide letter No. 02/COM/REP./S.E./N.H. 10th dated 02.01.2024 that the bidder himself could not submit requisite physical tender document as per the clause 12.2 of section-2, Instructions to bidder of RFP.
7. Member secretary informed that all the necessary/requisite documents of all the responsive bidders have been verified as per RFP at division level.
8. The Evaluation Committee, in this meeting held on 12.01.2024 evaluated bid of all the 03(Three) responsive bidders. The committee observed that the technical bids of all 03(Three) bidders were found technically responsive.

 - (ii) M/s N P Buildwell Pvt Ltd., 102 First Floor, Devika Chamber, RDC Rajnagar, Ghaziabad.
 - (iii) M/s Raja Infraconstruction Pvt.Ltd. B-38, RDC Rajnagar, Ghaziabad.
9. The committee deliberated and recommended that the financial bids of above 03(Three) responsive bidders to be opened on 19/01/24 at 15:00 PM as per RFP.
