Tender was invited by Executive Engineer, NH Division, Gaya vide NIT No: 07-NH/GAYA/DPR/2023-24 dated 24.11.2023 with bid due date 09.01.2024 which was later modified to 24.01.2024 (Corrigendum-4).

3. Superintending Engineer, N.H. Circle, Dehri-on-Sone vide its letter no. 78(we) dt. 24.02.2024 submitted the proposals of Proof of Eligibility of all the thirteen bidders.

5. Superintending Engineer, N.H. Circle, Dehri-on-Sone vide its letter no. 148(we) dt. 09.04.2024 informed that one non-responsive bidder M/s Spectrum Techno consultants Pvt. Ltd has submitted its representation stating that:

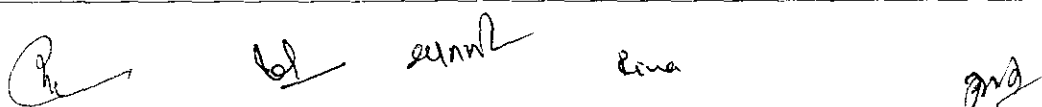
"As the Bid submission Packets are in 3 types viz, 1) Fee 2) Prequal/Technical 3) Finance on the submission portal. Hence, accordingly we have uploaded Fee of Bharatkosh Payment in 1) Fee Packet and in 2) Prequal/Technical- Proof of Eligibility and Technical Documents and 3) Finance-Financial Proposal."

6. The Evaluation Committee, in its meeting held on 26.04.2024 examined the representation of M/s Spectrum Techno consultants Pvt. Ltd. The evaluation committee found that Packet Type "**Fee**" has been clearly mentioned as "**Proof of Eligibility (Stage 1)**" in **Description** column on portal and hence deliberated that proof of eligibility should have been uploaded in packet type **Fee** only. Therefore, the Evaluation Committee declares M/s Spectrum Techno consultants Pvt. Ltd as non-responsive in proof of eligibility as the bidder has uploaded Bid fee Amount receipt (bharatkosh.gov.in) only and no other documents have been uploaded for Proof of Eligibility (Stage 1).

Further, the Evaluation Committee found that two bidders namely (i) Planning & Infrastructural Development Consultants Pvt. Ltd. and (ii) Monarch Surveyors And Engineering Consultants Pvt. Ltd. are blacklisted till 06.03.2025 by UP PWD and till 08.04.2025 by NHAI respectively as published on INFRACON. Hence the Evaluation Committee declare the bids of (i) Planning & Infrastructural Development Consultants Pvt. Ltd. in Association with MA Engineering Consultants Pvt. Ltd., New Delhi and (ii) M/s RODIC CONSULTANTS PVT. LTD. in JV with MONARCH SURVEYORS AND ENGINEERING CONSULTANTS PVT. LTD. New Delhi as non-responsive in proof of eligibility for the aforesaid reasons.

In view of para 6 above, the Evaluation committee declared the following 09 (Nine) bidders as responsive in Proof of Eligibility:

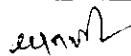

New Delhi have submitted their representation.
10. The Evaluation Committee. in its meeting held on 12.06.2024 examined the representations of (i) Planning & Infrastructural Development Consultants Pvt. Ltd. in Association with MA Engineering Consultants Pvt. Ltd..New Delhi and (ii) M/s RODIC CONSULTANTS PVT. LTD. in JV with MONARCH SURVEYORS AND ENGINEERING CONSULTANTS PVT. LTD. New Delhi in detail. The representation of the bidders and deliberations of the Committee is as follows:-

Hence the committee declared the bidder as responsive in proof of eligibility.







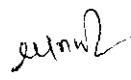

In view of above as well as terms of the RFP document, we kindly request you to reconsider the current evaluation and make the bid submitted as responsive.	The Evaluation Committee examined the representation and deliberated that the bidder shall not be declared non-responsive due to debarment after bid due date. Hence the committee declared the bidder as responsive in proof of eligibility.
