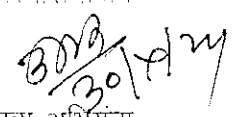

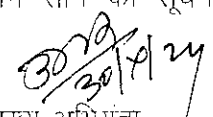

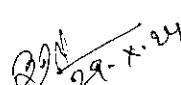
6. Executive Engineer, National Highway Division Gaya vide his letter no-873(we) dt. 18.01.2024 informed that the bidder named Planning & Infrastructural Development Consultants Pvt. Ltd. vide its letter no.- PIDCPL—HO/Morth-DPR-Bihar/2750 dt. 15.10.2024 submitted representation requesting to upgrade their claimed score to 96 based on instead of 79 as awarded by the Evaluation Committee.
7. The Evaluation Committee in its meeting held on 29.10.2024 reviewed the representation of bidder Planning & Infrastructural Development Consultants Pvt. Ltd. and deliberated that the Technical Score of 79 marks as awarded by the Evaluation Committee in its meeting dated 08.10.2024 is correct. Hence, the technical score remains unchanged.

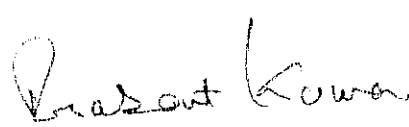

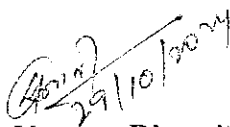
