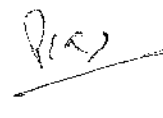

5. Superintending Engineer, NH Circle, Dehri-on-Sone vide letter no. 330(we) dated 02.08.2024 informed that two bidders namely (i) M/s Manglam Infra & Engineering Ltd., Bhopal vide its letter no. Ref. MIEL/2024/BIHAR/162 dt. 04.07.2024 and (ii) M/s Thoughts Consultants Jaipur Pvt. Ltd., Jaipur vide its letter dt. 04.07.2024 have submitted representations requesting for re-evaluating the technical proposals and revision of technical scores.

The bidder **M/s Manglam Infra & Engineering Ltd., Bhopal**, in its representation have submitted that they should be awarded (i), 10 out of 10 marks for Highway Professionals working with the firm in Firm's relevant experience, and (ii) a total of 90 marks each for Highway cum Pavement Engineer and Senior Bridge Engineer in Qualification and relevant experience of the proposed key personnel respectively.

The other bidder **M/s Thoughts Consultants Jaipur Pvt. Ltd., Jaipur** in its representation have submitted that they should be awarded 10 out of 10 marks for Highway Professionals working with the firm in Firm's relevant experience.

6. The Evaluation Committee on meeting dated 12-08-2024, went through the representation and documents submitted by both bidders **M/s Manglam Infra & Engineering Ltd., Bhopal** & **M/s Thoughts Consultants Jaipur Pvt. Ltd., Jaipur** and found that the claim for 10 out of 10 marks for Highway Professionals working with the firm in Firm's relevant experience is justified and they should be awarded 10 marks for Highway Professionals working with the firm in Firm's relevant experience. However, no other claims of **M/s Manglam Infra & Engineering Ltd., Bhopal** for revision of marks for Highway cum Pavement Engineer and Senior Bridge Engineer in Qualification and relevant experience of the proposed key personnel are justified and hence no change will be made in marks for Qualification and relevant experience of the proposed key personnel.

7. In view of above, the Evaluation Committee declares that the final technical score and score of team leader of 11(Eleven) technically Responsive bidders is as follows :-
