

Minutes of Meeting of Technical Evaluation Committee held on 29.12.2023 at 11.00 AM in the Chambers of the Chief Engineer, National Highways, Bengaluru for evaluation of technical bids for the work of 'Improvements to road from Bannahalli to Kummegowdana Doddi connecting Yarandappanahhali and Gulanahalli from Km 0.00 to 7.00 and Improvement to road from Bevinamarada Doddi to Kelagana Kebbare via Kebbare from Km.0.00 to 14.50 in Kanakapura taluk (Job no.CRF/KNT/2017-18/2359)' taken up under CRF 2017-18 pertaining to NH Division, Bengaluru

The meeting of the Technical Bid Evaluation Committee comprising of the following members as per CNH/CE/DCE/TA2/TENDER/2017-18/1336 Dated 20.06.2017 was convened on 29.12.2023 in the chambers of Chief Engineer, National Highways, Bengaluru.

At the beginning of the meeting, the Executive Engineer, NH Division, Bangalore gave a brief introduction of the project. It was reported that, the Under Secretary, Public Works Departments, Government of Karnataka has communicated Administrative approval to the work "Improvements to road from Bannahalli to Kummegowdana Doddi connecting Yarandappanahhali and Gulanahalli from Km 0.00 to 7.00 and Improvement to road from Bevinamarada Doddi to Kelagana Kebbare via Kebbare from Km.0.00 to 14.50 in Kanakapura taluk (Job no.CRF/KNT/2017-18/2359)" vide their letter No. PW/20/CRF 2023(E) Dtd:-23.11.2023.

Further, the Chief Engineer, National Highways, Bengaluru has accorded Technical sanction vide letter no. 2122 dated 24.11.2023 and same has been registered vide CER No.20/2023. Accordingly, short term tender has been invited vide NIT 12/2023-24 dated. 29.11.2023, through <https://eprocure.gov.in> duly obtaining approval from the Superintending Engineer, National Highway Circle, Bangalore vide letter no 1944 dated:28.11.2023.

Subsequently, the technical evaluation committee evaluated the bids with respect to following tender documents criteria's

- 3) Work done certificate for similar nature of works - single prime contractor as per clause 2.6.3(b)
- 4) Financial position (Cl.2.6.6)
- 5) Audited balance sheets (Cl.2.6.7),
- 6) Personnel capabilities (Cl.2.6.4),
- 7) Equipment as per Annexure - II vide section-1 read with special conditions under section 3 of SBD (Cl.2.6.5),
- 8) Bid Capacity as per Cl.2.6.9,

As per Clause 16.3 of tender document which states that;

"Any bid not accompanied by an acceptable Bid Security and not secured as indicated in Sub-Clauses 16.1 and 16.2 shall be rejected by the Employer as **non-responsive**".

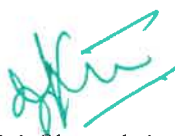
In the Instant bidding, the bidders Sri. Ashok S, Bengaluru, M/s Professional Global Infrastructures Pvt Ltd, Bengaluru and Sri Athmanada P S, Mandya have not furnished Bid security. Hence, the committee opined further not to evaluate the bid of the above bidders and to evaluate the bids of M/s Civil Technologies & Infrastructure Pvt Ltd, M.D. Abhishekh R, Bengaluru & M/s Star Infratech, Bengaluru.

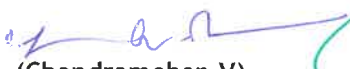

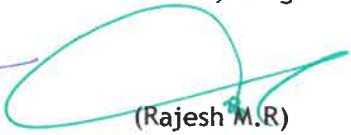
The Committee directed the Executive Engineer, NH Division, Bangalore to open the financial bids of responsive bidders as per tender conditions after duly uploading the proceedings;

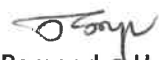
