4. The Evaluation Committee has examined the Technical Bids of the above two bidders, and bidder at Sr. No. 2 i.e M/s N K Bhatia & **CO** does not

satisfy eligibility criteria as he fails in major criteria of Bid Capacity, and Annual Turnover, hence declared as Non Responsive.

Bidder at Sr. No 1. M/s Rane Constructions satisfies the eligibility criteria fully, as well as mandatory requirement for online submission and hard copies and qualify for opening of Financial Bid.
