5. In meeting the bidder was qualified with remarks as mentioned below:

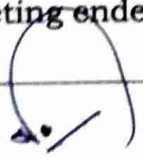
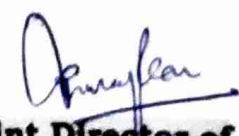
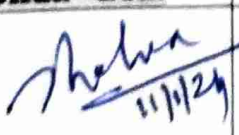
