

Minutes of the Meeting of Evaluation Committee held on 13th Feb, 2023 at 1200 Hr at the Office of the Chief Engineer PWD (NH) for the work, "Short Term Maintenance Contract to NH-202 (Old-155) from Km 0.00 to Km 39.00 under NH Division Tuensang in the State of Nagaland." Job. No: RW/GHT/NG/STMC/2023-24/9

The work under consideration has been accorded sanctioned by the Ministry amounting to Rs. 496.00 Lakhs Cr vide Ministry letter No.NH-15017/68/2023-P&M dated 24th Jan 2024. The estimated amount put to tender is Rs. 457.57 Lakhs.

2. The tender for the above mentioned work amounting to Rs. 457.57 Lakhs was invited by the Chief Engineer PWD (NH), Nagaland on 07.12.2023 and opened on 09.01.2024. The Bid due date for online submission was 08.01.2024 and the physical form of the bids was to be submitted till 1300 Hrs of 09.01.2024.

3. A Total of 5 (five) bids were received physically and online on www.eprocure.gov.in/eprocure/app from the following bidders:

4. Upon examination of Original Bid documents of M/s A. Pongshi Phom & Sons, it was observed that the Bid Security (Bank Guarantee) was not in accordance with the format provided in Section-4 of SBD. Accordingly, in accordance with clause 16.3 of the RFP, the bid of M/s A. Pongshi Phom & Sons is not considered and hence their bid is disqualified.

5. Based on the documents placed before the Bid Evaluation Committee, the committee examined the technical bid of the 4 (Four) bidders (The detailed evaluation sheet is enclosed herewith).

- i) For the Bid of M/s Pele Khezhie, a letter regarding clarification of his bid was send via email on 6th February 2024 to provide clarifications/ additional documents on or before 08.02.2024. Having received no response from the bidder, the Bid evaluation committee deliberated on the matter and found the bidder to be technically non-responsive in accordance with clause 4 and clause 26 of the RFP.

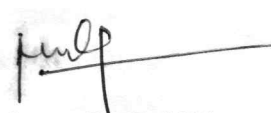
