

Minutes of meeting of Evaluation committee held on 22.08.2024 @1500 Hrs. for the work "Consultancy Services for preparation of DPR for upgradation of single lane to 2-lane and tunneling of existing alignment/ realignment from Chainage 68.600 to 75.00 of NH- 107 (Sitapur-Sonpryag-Gaurikund Section) (Total Length 17.50km including 2km of Tunnel) in the State of Uttarakhand."

Bids for the subject work were invited online by the o/o Regional officer, MoRTH, Dehradun, on 11.12.2023 as per extant norms. The consultancy work is to be executed by State PWD, Uttarakhand. The Bid due date of subject work was 01.02. 2024. Online Bid was opened by tender evaluation committee on 02.02.2024 out of 02 bidders 1 bidder is found technically responsive. The MOM of Technical evaluation is enclosed as Annexure A. The result of technical evaluation was uploaded on e-procurement portal on 05.08.2024 and the same was mailed to all bidders (Annexure B).

2. One bidder was disqualified due to overall score of the bidder was less than 75 as per Section 2 LOI clause 3.2.4 Para ii of RFP. Representation of disqualified bidder on the technical evaluation have been received. In the disqualified bid, CV of 2 key person Tunnel Design Expert and Senior Geotechnical Engineer was not evaluated due to proof of essential qualification as per TOR, Enclosure-II of RFP was not found. The representation of the bidder vide letter dated 07.08.2024 has been pursued by State PWD and O/o CE-RO. Score obtained in respect of experience of firms, Material testing, Survey equipment to be used, Qualification & experience of Key Person is tabulated as follow:

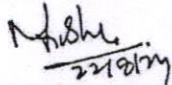
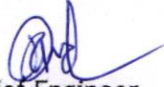
- In this regard the translated degree certificate & University website have been perused and it was found that the relevant bachelor degree required to enroll in the course is civil engineering. Therefore, score (20) against essential qualification may be considered.
- Further the document submitted for Desirable qualification i.e. post-graduation degree is Diplom-Ingenieur which is as per the submission of the bidder is equivalent to Masters in civil Engineering, further the degree certificate does not indicate any specialization. This is not as per the stipulated requirement of TOR enclosure II of RFP i.e. Post-Graduation in Design/Structural engineering or equivalent. Therefore, in respect of desirable qualification zero marks may be given.
- The cv of Tunnel Design Expert has been evaluated as per stipulated RFP criteria and 5.06 marks may be considered.

v. In respect of Senior Geotechnical Engineer (Stefan Dietrich) evaluation criteria Appendix IV Clause 2.4.16.

- The bidder vide its representation letter dated 07.08.2024 has submitted that "Mr. Stefan Dietrich, proposed as Sr. Geotechnical Engineer, holds a master's degree (MSc) in Civil Engineering with specialization in Geotechnics/Tunnelling, Water Engineering and Alpine Technology from University of Innsbruck, meeting the required criterion. The degree named "Dipl. Ing." in German language, "Diplom" refers to post-graduate degrees. We have attached a degree equivalency proof for your reference along with translated copy of the degree".
- In this regard the translated degree certificate & University website have been perused and it was found that the relevant bachelor degree required to enroll in the course is civil engineering. Therefore, score (20) against essential qualification may be considered.
- Further the document submitted for Desirable qualification i.e. post-graduation degree is Diplom-Ingenieur which is as per the submission of the bidder is equivalent to Masters in civil Engineering, further the degree certificate does not indicate any specialization. This is not as per the stipulated requirement of TOR enclosure II of RFP i.e. Post Graduation in Geotechnical Engineering /Foundation Engineering/Rock Mechanics/Geo science or equivalent.

						Therefore, in respect of desirable qualification zero marks may be given. The cv of Senior Geotechnical Engineer has been evaluated as per stipulated RFP criteria and 5.40 marks may be considered.
