2. The work "Short Term Maintenance from Km 154.000 to 173.600 on NH-72B(New NH-707) in the state of Uttarakhand" was sanctioned vide Ministry's letter No. RO/UK/STMC/2023-24 (Computer No. 230702) dated 22.12.2023 for Rs. 5.00 Crore, (Job. No. RO/UK/STMC/2023-24/19). The cost of work proper is Rs. 3.90 Crore (Excluding GST).
3. The bid for the instant work was invited as per Ministry's Guidelines by the Superintending Engineer, 10th N.H. Circle, PWD, Dehradun vide letter No. 10016/13Yata-NH-10/2023 dated 12.12.2023. The bid due date was fixed as 11.01.2024 while opening of online received bids was scheduled on 12.01.2024.
4. The following 07(Seven) bidders made physical submission as per ITB of RFP. Hence technical bids of the following 07(Seven) bidders were admitted for opening of their technical part of the bid online on 12.01.2024.

5. Member secretary informed that all the necessary/requisite documents of all the 07(Seven) bidders have been verified as per RFP at division level.
6. The bid submitted by remaining 05(Five) Bidders have been found Technically non-Responsive for the reasons mentioned below :-

Undertaking regarding availability of minimum cash amounting to 25% of the value of work during implementation of the contract towards working capital Non submitted in affidavit duly notarized (as per the format provided in Section-3) as per clause 12.2(V) of RFP4. Required Qualification of Site Engineer Doesn't Match as per ITB. 4. Bidder submitted the qualification of Site Engineer as Diploma Holder, which is not as per the requirement of clause 4.3B (b) (ii) Appendix to ITB. It is clearly mentioned in clause 4.3B (b) (ii) Appendix to ITB that "The signed CVs must be uploaded along with the bid. Non compliance of the non furnishing of the CV as or conditional deployment of any of personnel of proposal to employ lesser number of personnel than above shall make the bid non responsive and financial bid not to be opened". 5. D.D. of Rs. 1800/- (GST of Tender Fees) is submitted by the Third Person, neither by the Company nor by any of the Partner. 1. Certificate of Application to BID on BIMS not Submitted/not uploaded online. As per the Section-1 (4), Notice Inviting Tender, it is clearly mentioned "To participate in the bidding, it is mandatory for the bidders to get registered their firm with e-procurement portal..... Bidders are also required to get registered with Bidder Information Management System (BIMS) Portal". 2. Methodology and construction programme Not Submitted. 3. Documents regarding Owning/Leased/Rented for Tipplers & Back hoe Loader is not Submitted/uploaded by the bidder. As per Appendix to ITB clause 1.1, it is clearly mentioned that "The bidder must upload scanned copy of the documentary evidence in support of his owning/leased/rented of the equipment's..... Any conditional evidence of deployment of equipment or inadequate proof as required for any of the equipment shall make the bid non-responsive and financial bid shall not be opened". 4. The bidder did not uploaded the Signed Curriculum Vitae (CV) of Key Staff, which is not as per the requirement of clause 4.3B (b) (ii) Appendix to ITB. It is clearly mentioned in clause 4.3B (b) (ii) Appendix to ITB that "The signed CVs must be uploaded along with the bid. Non compliance of the non furnishing of the CV as or conditional deployment of any of personnel of proposal to employ lesser number of personnel than above shall make the bid non responsive and financial bid not to be opened".

7. The Evaluation Committee, in this meeting held on 17.01.2024 evaluated all the 07(Seven) received bids. The committee observed that out of 07(seven) Bidders the technical bids of only 02 (Two) Bidders were found Technically Responsive.

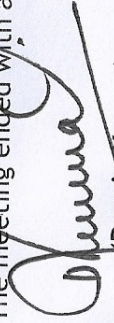

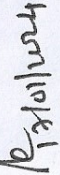

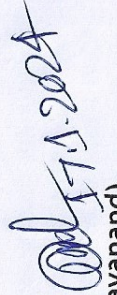
