

Rehabilitation & Upgradation of NH 753B from Nandurbar to Taloda (Km. 49+050 to Km. 78+270) to Four lane with Paved Shoulder in the States of Maharashtra/Gujarat on EPC mode. (Length=29.220 Km).

With respect to the bid for subject work, Minutes of meeting dated 18.06.2024 regarding technical evaluation is enclosed.

2. Financial bid will be opened on 01.07.2024 at 3:00 PM.

Minutes of meeting of Evaluation Committee held on 18.06.2024 under the chairmanship of CE (Zone-west) MORT&H for evaluation of Technical bids for the work of " Rehabilitation & Up-gradation of NH-753B from Nandurbar to Taloda (Km. 49+050 to Km. 78+270) to Four lane with Paved Shoulder in the States of Maharashtra/Gujarat on EPC Mode" (L-29.220 Km.)"

The tenders for the above-mentioned work were called vide Tender ID: 2023_MoRTH_786505_1 on 20.12.2023 for an amount of Rs. 608.47 Cr with Bid submission end date as 04.03.2024 @ 5:00 pm and Bid opening date as 05.03.2024 @ 14:00 hrs. The bid was invited on 20.12.2023 by CE-RO MoRT&H Mumbai through e-tendering Portal <https://eprocure.gov.in/eprocure/app>. The Technical bids were opened on 11.03.2024 @ 15:30 hrs in CE-RO MoRT&H Mumbai office in the presence of Members of the Evaluation Committee and total 11 bids were received.

2. The Evaluation Committee again met through Video Conference in its meeting on 18-06-2024 @ 12.30 PM for evaluation of technical bids of the above-mentioned work and recalled that the Evaluation Committee in its previous meeting dated 14.05.2024 decided to seek the clarifications from the bidders M/s. BNA Infrastructure Pvt. Ltd. – M/s Ajaydeep Infracon Pvt. Ltd. (JV), M/s. KKB Projects Pvt. Ltd. –M/s Unique Constructions (JV), M/s. M.S. Khurana Engineering Ltd, M/s. Nirmal Buildinfra Pvt. Ltd, M/s. RRSM Infra Pvt. Ltd, M/s. Shivalaya Construction Co. Pvt. Ltd, M/s. Shri Swami Samarth Engineers Ltd, M/s. Swastik Infralogics Pvt. Ltd. – M/s Krishi Infratech (JV) and M/s. T&T Infra Ltd.- M/s Thakur Infra Projects Pvt. Ltd. (JV) which was to be submitted by them within 7 days time from the date of uploading the proceedings in e-tendering Portal on 21.05.2024 for further evaluation of their technical bids. All the above bidders have furnished their clarifications on the queries raised by the Evaluation Committee within the above stipulated time period.

3. The Evaluation Committee in this meeting deliberated on the clarifications furnished by the bidders and details submitted in their technical bids and finalized the responsiveness/non-responsiveness of the technical bids of these 11 bidders as under:

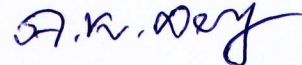

4. The BGs for Bid security of all the 11 bidders have been got verified by CE-RO, MoRTH Mumbai.







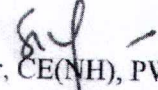

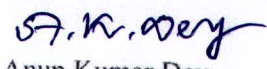
