

MINUTES OF MEETING OF TECHNICAL EVALUATION COMMITTEE HELD ON 16-02-2024 TO EVALUATE TECHNICAL BIDS FOR THE WORK "SHORT TERM MAINTENANCE AND ROAD PROPERTY MAINTENANCE FROM KM 46/00 TO 52/00 ON NH-07 IN THE STATE OF HIMACHAL PRADESH".

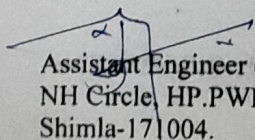
1. M/s S.S. Associates, Engineers & Contractors # 923, Sector-7, Urban Estate, Ambala City (HR)-134003.

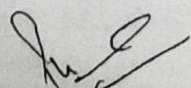

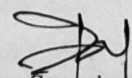
