

MINUTES OF MEETING OF THE TENDER EVALUATION COMMITTEE HELD FOR CONSIDERATION OF THE TECHNICAL BID FOR THE WORK “SHORT TERM MAINTENANCE CONTRACT FOR NH-306’A’ (65/00 TO 83/00 KMP) i.e 18.00 KM LENGTH FOR THE YEAR 2023-24 UNDER NATIONAL HIGHWAY DIVISION-II, AIZAWL IN THE STATE OF MIZORAM” (Job No. RW/GHT/STMC/MZ/23-24/5)

The tender evaluation committee for NIT No. 5/STMC/CE-HW/2023-24 Dt. 28.12.2023 had its meeting on **Dt.09.02.2024** to evaluate the Technical Bids of the work mentioned above.

1. The Ministry had accorded sanction to the following work as per the details given below:-

3. The cost of work put to tender is **Rs. 404.12 lakhs**. Accordingly, the bid security amount for the work comes upto **Rs. 8,08,000.00**.

4. The online technical bids submitted by the bidders were opened on 16th January, 2024 in the Office of Chief Engineer, Highways, Mizoram PWD, Aizawl. 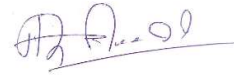
