

Minutes of Meeting of the Evaluation Committee for examination of representations received on result of Technical Evaluation held on 14.11.2024 at 4:00 PM under the chairmanship of CE NH PWD Bhopal for evaluation of Technical Bids for the work of Consultancy Services For Authority's Engineer For Supervision of "consultancy service for authority's engineer for supervision of CONSULTANCY SERVICES FOR AUTHORITY'S ENGINEER FOR SUPERVISION OF "Construction of Morena bypass, Ambah bypass & Porsa bypass (Total length 27.16km) and Ater realignment to Bind bypass (Total length 21.50 km) Section of NH-552 Ext. to Two lane with paved shoulder configuration in the state of Madhya Pradesh on EPC mode". 1. The online tenders for the above-mentioned work through e-tendering Portal <https://eprocure.gov.in/eprocure/app> was called by CE(NH), MPPWD, Bhopal vide Tender ID- 2023_MORTH_787790_1 on 29.12.2023. Bhopal with following bid details: -
 - i. Total Project length :48.66 Km.
 - ii. Total project cost :-Rs. 469 Cr.
 - iii. Bid due date -19.02.2024
2. Earlier, the meeting of Evaluation committee for Evaluation of technical Bids was held on 13.09.2024 & the result of Technical Evaluation was uploaded on e-Procurement portal on 21.09.2024. Also the meeting of the meeting for Evaluation of technical Bids on representation was held on 25.10.2024 & the result of Technical Evaluation was uploaded on e-Procurement portal on 12.11.2024. Further M/s Marc Technocrats Private limited has submitted representation for consideration of CV of Team Leader as per clause 3.4 of Section 2 of RFP and M/s Agnitio Infrastructure Projects Pvt. Ltd has also submitted the representation regarding CVs of key personnel. The Evaluation committee examined the representation and the details are as under:-

1.	M/s Marc Technocrats Private Limited has submitted that the Team Leader (Sh. Bhuyar Pundlik Ajabrao) was debarred by NHIDCL for a period of 6 months. Further it is submitted that CV of TL may be considered for evaluation as per clause 3.4 of Section 2 of RFP. 2.	M/s Agnitio Infrastructure Projects Pvt. Ltd. has submitted representation for re-evaluation of CVs of key personnel.	The Committee examined the representation in detail and no change is considered in the marks.
3.	NHAI vide letter no. NHAI/CG/2022/Durg-Raipur-Aurang/Pkg B/AE/140 dated 06.11.2024 debarred M/s Almondz Global Infra Consultant Limited from 15.02.2024 for the period of 02 years. Accordingly the bids of M/s AICONS Engineering Pvt. Ltd. in Joint Venture with Almondz Global Infra-Consultant Limited in association with TORCHBEARER will not be considered for financial opening as per Ministry's circular no. RW/NH-33044/76/2021-S&R(P&B) dated 04.01.2022	
4.	NHAI vide letter no. 19001/1/RO-W-UP/H-M/Consultancy Tender/E-124012/24530 dated 26.09.2024 debarred M/s Theme Engineering Services Pvt Ltd from 26.09.2024 for a period of 06 months and NHAI vide letter no. 19001/RO-W-UP/H-M/E-Tender/24801 dated 24.10.2024 mentioned that the debarment has been upheld by the Hon'ble High Court. Accordingly the bids of M/s Theme Engineering Services in Ass. With Ishita Info solution Pvt. Ltd. will not be considered for financial opening as per Ministry's circular no. RW/NH-33044/76/2021-S&R(P&B) dated 04.01.2022
