You shall promote and incorporate the “Concessionaire” as a limited liability company under the Companies Act 2013, as the entity which shall undertake and perform the obligations and exercise the rights of the Bidder under the LOA, including the obligation to enter into the Concession Agreement pursuant to the LOA for executing the Project. The Concessionaire shall, for the performance of its obligations hereunder during the Construction Period, provide to the Authority no later than 30 (thirty) days from the date of agreement, an irrevocable and unconditional guarantee from a Bank for a sum equivalent to Rs. 23,97,00,000.00/- (Rupees Twenty Three Crores and Ninety Seven Lakh Only in the form set forth in Schedule-F (the “Performance Security”).

4. You are required to comply with all the terms and conditions set forth in the RFP documents and subsequent addendum/corrigendum issued. In case of any default on your part, you shall be liable for action as stated in the RFP Document.
