Result of Technical Bid Evaluation (Revised)

With reference to the result of technical bid evaluation dated 06.02.2023 and received representation(s)/objections thereto, the tender committee has deliberated upon the received representations and accorded its recommendations, as under:

1	We are glad to know that we have been found technically qualified for the Tender. We also observed that Scientific Security Management Services Pvt. Ltd. and Shree Ram Enterprises have been found eligible. As per the page nos. 12 and 13 of the RFP (Tender Document), it is instructed to submit Attested Copies (Not Self Attested) of PAN, GST, EPF and ESIC Certificates. But both the firms i.e. Scientific Security Management Services Pvt. Ltd. and Shree Ram Enterprises have not submitted the Attested Copies of Documents in question. You are requested to kindly look into the matter and revise the qualification status of the bidders which are Scientific Security Management Services Pvt. Ltd. and Shree Ram Enterprise	Objection raised does not account for any substantial material deviation or inconsistency and therefore no further action required.
2	M/s. Marshal Industrial Security (Regd) made representation against their bid being non-responsive, citing clause 4.1 c of section II.	All the three bidders were non-responsive on account of clause 4.1 c) of section II, which states,

3	M/s. Sumit Safe Security Pvt. Ltd. made representation against their bid being non-responsive, citing that they have the required documents as the criteria. Further, brief summary of same was presented therein.	<i>"To qualify for award of the Contract, the bidder should have successfully & timely completed Works of similar nature with minimum one work of ₹ 8,15,32,339/- or two works of ₹ 5,09,57,712/- each or three works of ₹ 4,07,66,170/- each during last 5 years in Government Organization, Public Sector Undertaking, Autonomous Body duly funded by Govt. of India/ State Govt., Private Sector of repute only. Contractor should submit documentary evidence such as Letter of Award, copy of contract agreement, and certificates of satisfactory completion of work from the previous Employer otherwise, the experience will not be considered for evaluation and the bids will be rejected."</i>
4.1	M/s. NPS Facilities made representation that they qualify the criteria mentioned as per the clause 4.1 c) of section II.	These bidders had submitted work order of appropriate value, as required to qualify. However, the duration of submitted work was more than 24 months and upon prorating same for 24 months, the calculated work order value, as required from similar work, happened to be less than the required amount. Keeping in view the individual responses and the existing terms of RFP w.r.t. definition of work of similar nature, such WO may be considered.
4.2	M/s. NPS Facilities has submitted POA as per the clause 4 of section I.	The committee observed that digital signing had been done by Mr. Vikas Singh, Proprietor and now POA had also been submitted in favor of Mr. Vikas Singh. Submission may be accepted.
5	M/s. Shree Consultancy Services has informed that due to oversight their authorized person signed the tender documents instead of their proprietor, who is not digital signatory.	The committee observed that Mr. Bandana Kumar is the digital signatory and POA had been granted to Mr. Pritesh Salaskar, Tender Executive by Mr. D. V. Shinde, Proprietor. As such, requirement of clause 4 of section I, is not fulfilled and therefore bid is still non-responsive.

2. Taking into account above recommendations duly approved by the competent authority, the revised status of technical evaluation may be reckoned as under:
