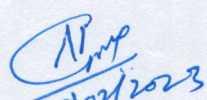
3. From the above Statement, it can be seen that M/s. Arnav Construction has quoted a lowest offer of Rs.60,09,759.73 Ps (Say Rs.60,09,760/-) i.e. 21.11% below the estimated cost of Rs.76,17,898/-. The Committee declared, M/s. Arnav Construction is L1 Bidder.
4. As per Policy Circular No. Technical (177/2015), dated 17.04.2015, powers delegated to Regional Officer to approve the lowest bid price is upto 5% above the estimated cost.
5. In view of the above, Committee recommends that the subjected work may be awarded to the L1 Bidder, M/s. Arnav Construction with a quoted offer of Rs.60,09,760/- i.e. 21.11% below the estimated cost of Rs.76,17,898/-.
