- As per Clause 2.10.1 of RFP, within 7 (Seven) days from the date of issue of this LOA, you are required to submit a Performance Security consisting of (a) a crossed account payee demand draft/Pay Order, amounting to **Rs. 1,98,53,000/- (Rupees One Crore Ninety Eight Lakh Fifty Three Thousand Only)** and (b) a bank guarantee valid for a period of 14 (Fourteen) months from the Date of LOA, in the prescribed format for **Rs. 1,98,53,000/- (Rupees One Crore Ninety Eight Lakh Fifty Three Thousand Only)**.
- The Bid Security of **Rs. 33.84 Lakh** shall be forfeited by the Authority in case you fail to furnish the required Performance Security within the specified period, out of common bid security (BG) available with the Authority. As per Clause 3.6 of RFP, you shall also be required to sign the contract within **Three (03) days** from the date of submission of the Performance Security, take over the toll plaza and start the user fee collection within **Two (02) days** of signing the contract agreement and on failure to do so, the entire Performance Security including the bank guarantee is liable to be forfeited and invoked.
