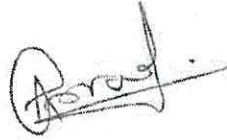

- 4 M/s Shree Ganesh Tours and Travels has submitted Financial Bid along with Technical Bid documents, which is not in accordance with condition of tender documents.

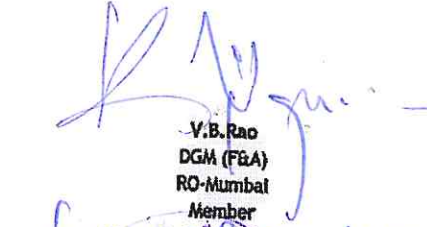
In view of above Evaluation Committee recommends to re-invite bids. The VC meeting concluded with vote of thanks to the Chair.
