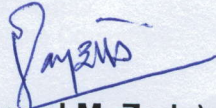

In continuation to the Minutes of opening, the Committee evaluated the Bids of the all the Bidders.

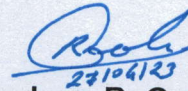

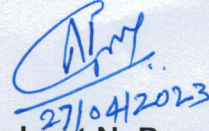
