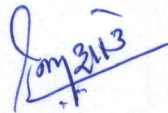
4.0 As per the technical evaluation, the technical scores obtained by the firms are as follows:

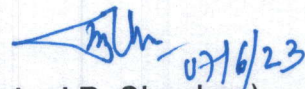
5.0 As per Clause-5.8 of ITC, combined technical & financial scores obtained by the firms are as follows:

- 6.0 M/s. Dhruv Consultancy Services Ltd. In Associate with M/s. Cividesign Consultant Pvt. Ltd. has scored highest score of 97.14% of combined technical & financial evaluation with financial offer of Rs.5,58,00,000/-.
- 6.1 As per Clause-5.8 of RFP, the firm achieving the highest combined technical financial score shall be declared as the most preferred bidder. Hence, Committee declared M/s. Dhruv Consultancy Services Ltd. In Associate with M/s. Cividesign Consultant Pvt. Ltd. as most preferred Bidder / H1 Bidder.
- 7.0 In view of the above, Committee recommends that the captioned work may be awarded to the H1 Bidder, M/s. Dhruv Consultancy Services Ltd. In Associate with M/s. Cividesign Consultant Pvt. Ltd. who offered an amount of Rs.5,58,00,000/- having highest score 97.14% of combined technical & financial evaluation.

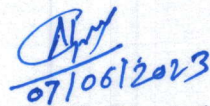
