Minutes of Meeting of Tender Evaluation Committee (Financial Evaluation) dated 19.04.2023 for the work of "Providing, Running & Maintenance of 3 Nos. commercial vehicles [Indigo (or) Equivalent Type] on hire basis (Tender Ref. No. NHAI/PIU/DGL/ Vehicle2023-24) - (Third Call) (Tender ID: 2023_NHAI_144878_3)"

1. Committee evaluated technical bids and recommended the following;

2. Subsequently, the technical evaluation was uploaded in Government CPP Portal on 13.04.2023 and financial bid opening was scheduled at 15.15 Hrs. on 13.04.2023.

3. Consequently, financial bids submitted by technically qualified bidders have been decrypted at the scheduled time and amounts quoted by them are as under;

Name of Bidder	Bid ID	Amount Quoted (Rs.)
M/s VETRI AGENCY, DINDIGUL	541706	2,25,000/- for providing 3 No. of Vehicles per month. [Rs. 20/- per Km for additional Km beyond the monthly ceiling limit of 3000 Km/Per month/per vehicle].

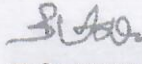
4. As above, the rates quoted by the bidder, M/s Vetri Agency, Dindigul is for Rs. 2,25,000/- for providing 3 No. of Vehicles (Indigo/Equivalent) per month and [Rs.20/- for additional Km beyond the monthly ceiling limit of 3000 Km per vehicle], which is considered to be on higher side than the nominal rates, hence, the Committee has opined that, the rates quoted by the bidder is not reasonable and workable.

5. In view of the above, it is concluded that, duly considering the single bid & rates quoted by the bidder is on higher side, which has created necessity to provide another opportunity to invite fresh bids to create healthy competition amongst the bidders and to receive reasonable rates.

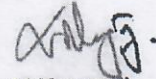
6. Further to mention that, consequent upon the joining of Manager (Tech) in PIU-Dindigul w.e.f. 10.04.2023 (FN), it has been desired to hire a Vehicle [Bolero or Scorpio/Equivalent] for the services of Manager(T), PIU, Dindigul which may also be included in the fresh bid documents.



In view of the above, the Tender Evaluation Committee unanimously recommends to invite E-Bids under separate tender ID for "Providing, Running & Maintenance of 1 No. of Vehicle [Bolero/Scorpio or Equivalent] for the purpose of Manager (T), PIU, Dindigul and 3 Nos. commercial vehicles [Indigo (or) Equivalent Type] for the purpose of Site Engineers deputed in PIU, Dindigul, on hire basis for a period of One Year".
