

**NATIONAL HIGHWAYS AUTHORITY OF INDIA

Minutes of the Meeting of Technical Evaluation Committee (Technical Bid) dated
10.04.2023 for the following;

"Providing, Running & Maintenance of 3 Nos. commercial vehicles [Indigo (or) Equivalent Type] on hire basis (Tender Ref. No. NHAI/PIU/DGL/ Vehicle2023-24) - (Third Call) (Tender ID: 2023_NHAI_144878_3)"

1. PIU, Dindigul invited E-bids vide Tender ID: 2023_NHAI_144878_3 for providing, running & maintenance of 3 Nos. of Commercial Vehicles on hire basis for the office use of PIU, Dindigul, bid documents for the subject tender work has been uploaded in CPP Portal to invite e-bids vide Tender ID: 2023_NHAI_142622_1. However, there was no bids received in the CPP Portal. Hence, it was decided to invite fresh bids under separate Tender ID.
2. As such, fresh bids were invited vide Tender Ref No: 2023_NHAI_144878_1 vide first call i.e., to fire 3 No. of Commercial Vehicles viz., Indigo or equivalent type. Consequent upon non-receipt of bids, subsequent calls i.e. second call (2023_NHAI_144878_2) and third call vide Tender Ref. No. 2023_NHAI_144878_3 was invited and scheduled time for submission of bids as 15 days. Accordingly, last date of submission of bids is on 03.04.2023 upto 11.00 AM & the date of bid opening is scheduled on 04.04.2023 @ 11.00 AM. Accordingly, 1 No. of E-Bid was only received within the stipulated time (Tender ID: 2023_NHAI_144878_3).
3. Further to mention that, this office vide Office Order No. NHAI/PIU/DGL/Site Engineer/Vehicle Tender/2023/215 dated 23.01.2023 has constituted the following Committee for evaluation of Vehicle tender bids;

5. The Committee has evaluated the single bid based on the available scanned copy and the abstract of evaluation is submitted as under;

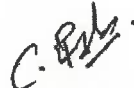
